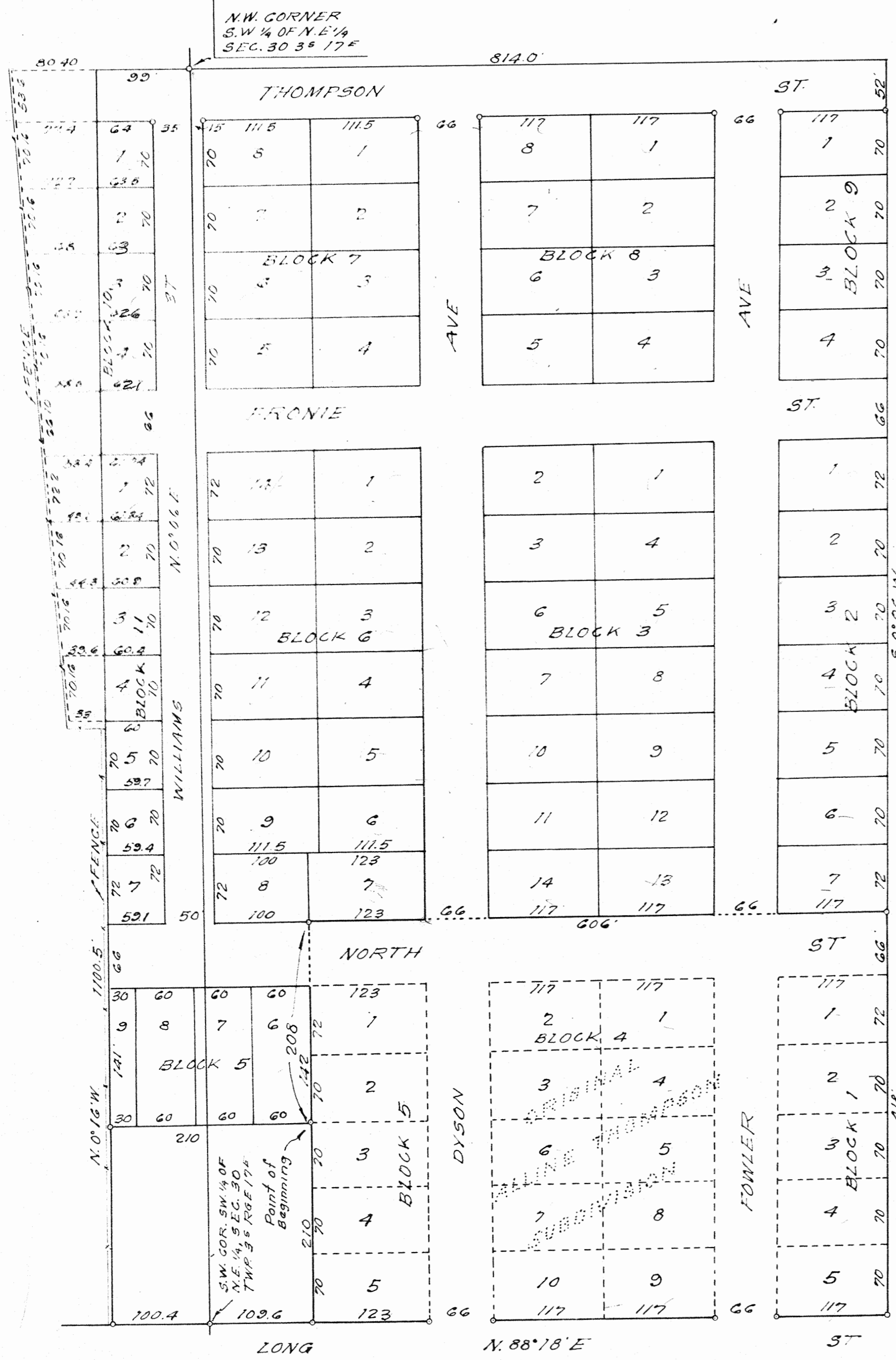


ALLINE THOMPSON SUBDIVISION ADDITION N^o 1

A PART OF THE S.E. OF NW. AND A PART OF THE SW. OF N.E. SECTION 30,
TWP 3 S., RGE. 17 E., COLUMBIA COUNTY, FLORIDA

DESCRIPTION

COMMENCE AT THE SOUTHWEST CORNER OF THE S.W. 1/4 OF N.E. 1/4 OF SECTION 30, TOWNSHIP 3 SOUTH, RANGE 17 EAST, COLUMBIA COUNTY, FLORIDA AND RUN EAST ALONG THE SOUTH LINE OF SAID S.W. 1/4 OF N.E. 1/4 100.6 FEET THENCE RUN NORTH 210 FEET FOR A POINT OF BEGINNING, AND RUN THENCE WEST 210 FEET; THENCE RUN NORTH 100.5 FEET PARALLEL TO THE WEST LINE OF SAID S.W. 1/4 OF N.E. 1/4 TO A POINT 99 FEET WEST OF THE NW. CORNER OF S.W. 1/4 OF N.E. 1/4 OF SECTION 30, THENCE RUN EAST 814 FEET, THENCE RUN SOUTH 802 FEET; THENCE RUN WEST 606 FEET THENCE RUN SOUTH 206 FEET TO THE POINT OF BEGINNING.
