


# BAKER HEIGHT'S SUBDIVISION

**DESCRIPTION:-**

Begin at a point on the North line of the N.W. 1/4 of the S.W. 1/4 of Section 32, Township 3-South, Range 17-East, Columbia County, State of Florida where said North line crosses the South line of PARK STREET, said point being 68 Feet N. 88° 09' E. from the N.W. Corner of said N.W. 1/4 of S.W. 1/4 and run thence N. 88° 09' E. 471.83 Feet, thence S. 1° 06' E. 129.73 Feet, thence N. 86° 51' E. 420 Feet, S. 0° 29' E. 767.93 Feet, thence S. 63° 16' W. 147.4 Feet, thence N. 26° 44' W. 190 Feet, thence 49° 22' W. 82.6 Feet, thence N. 56° 42' W. 71.3 Feet, thence N. 49° 22' W. 490 Feet, thence N. 41° 14' W. 70.7 Feet, thence S. 89° 58' W. 95.6 Feet, thence N. 0° 22' E. 241.1 Feet, thence N. 45° 22' W. along the South Right of Way line of PARK STREET, 74.1 Feet to Point of Beginning, Except Right of Way of PARK STREET, said Lands lying and being wholly within the N.W. 1/4 of S.W. 1/4 of SEC. 32, Township 3-South, Range 17-East, Tallahassee Meridian.
