
# - COUNTRY

A SUBDIVISION OF A PART OF THE N.W. 1/4 OF THE S.W. 1/4, SECTION 11, TSP. 4 SOUTH, RANGE 16 EAST COLUMBIA COUNTY, FLORIDA



#### DESCRIPTION

BEGIN AT THE S.E. CORNER OF THE N.W. 1/4 OF THE S.W. 1/4, SEC. 11, TSP. 4 S, R 16 E AND RUN THENCE S89°13'W ALONG THE SOUTH LINE OF SAID N.W. 1/4 OF THE S.W. 1/4, 1320' FEET TO THE WEST LINE OF SAID SEC. 11, THENCE RUN N 0°33'W ALONG SAID WEST LINE, 471.5 FEET TO THE SOUTH R/W LINE OF STATE RD. NO. 247, THENCE RUN N 41°30'E ALONG SAID SOUTH LINE, 388.6 FEET, THENCE RUN N 89°13'E, PARALLEL TO SAID SOUTH LINE OF THE N.W. 1/4 OF THE S.W. 1/4, 1060.8 FEET TO THE EAST LINE OF SAID N.W. 1/4 OF THE S.W. 1/4, THENCE RUN S0°33'E ALONG SAID EAST LINE, 759.0 FEET TO THE POINT OF BEGINNING. SAID LANDS LYING IN AND BEING A PART OF THE N.W. 1/4 OF THE S.W. 1/4, SEC. 11, TSP. 4 S, R 16 E AND CONTAINING 22.1 ACRES MORE OR LESS.
