ALONG THE SOUTH LINE OF PUTNAM STREET 314.3 FEET, THENCE S. 6° 50' W. 165 FEET, THENCE S. 87° 43' W. 197.5 FEET TO THE EAST LINE OF BAKER AVE., THENCE S. 6° 50' W. 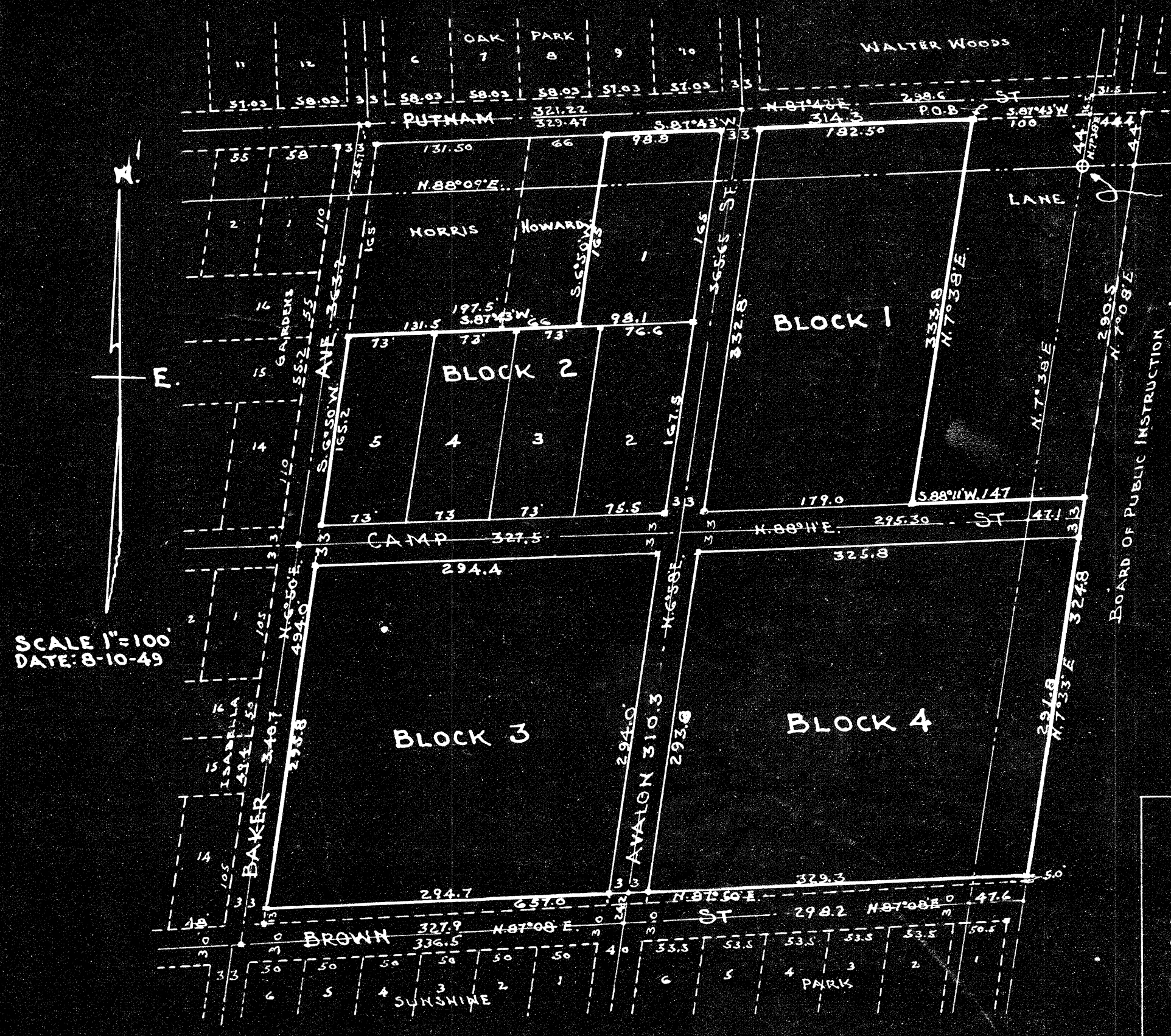

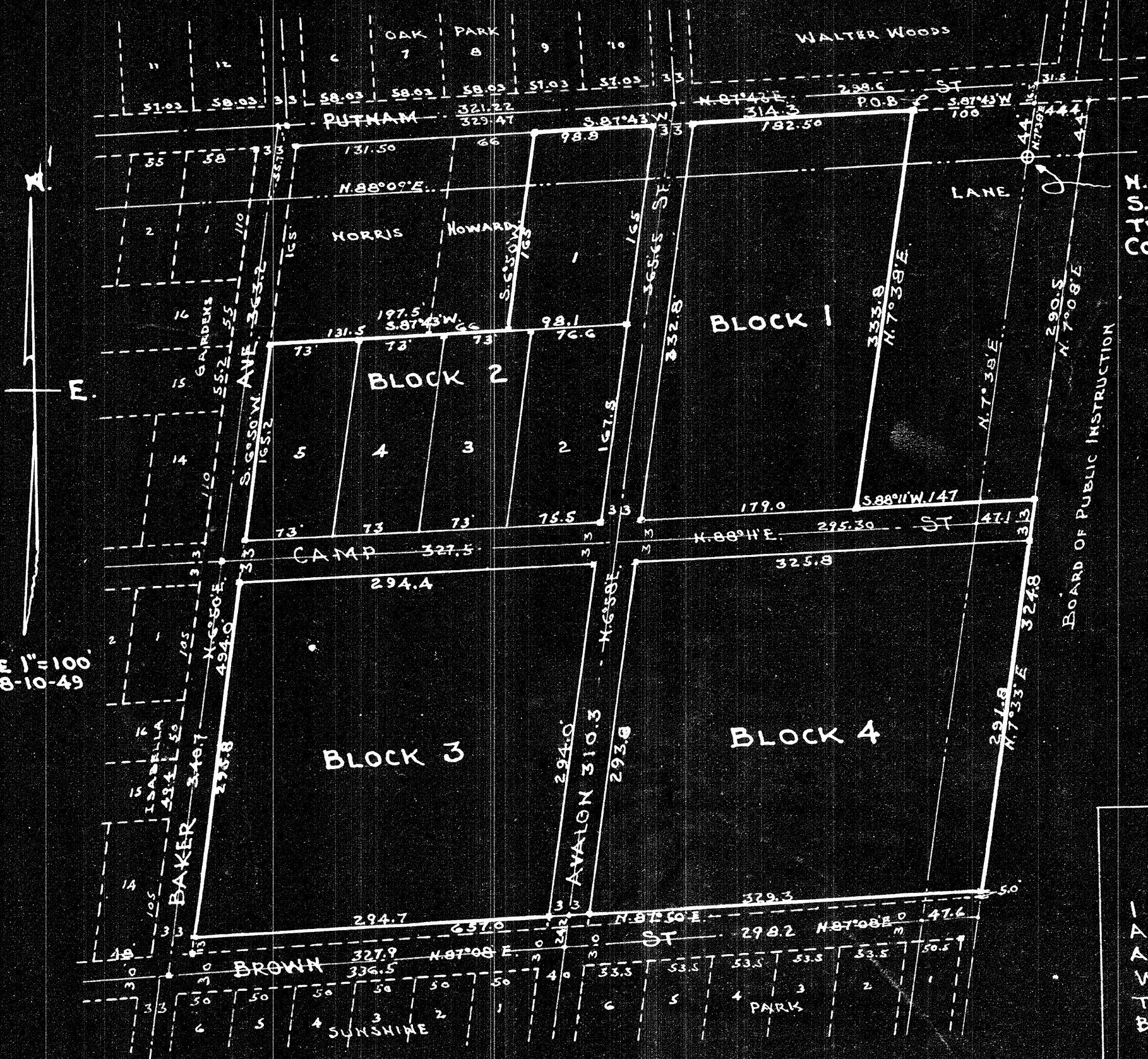
