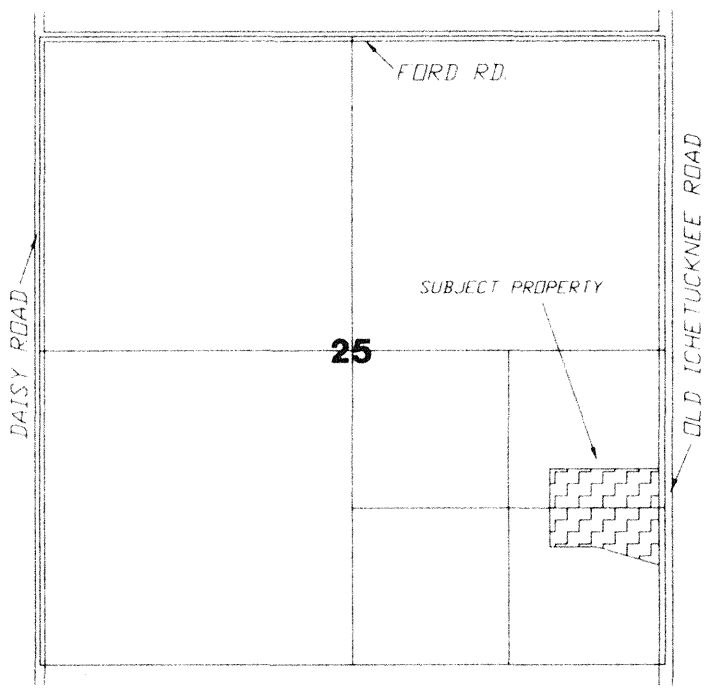

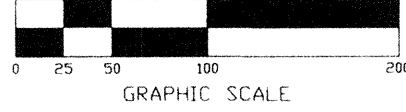
SECTION 25 TOWNSHIP 5 SOUTH, RANGE 15 EAST

SURVEYOR'S NOTES:

- BOUNDARY BASED ON MONUMENTATION FOUND IN ACCORDANCE WITH THE RETRACEMENT OF THE ORIGINAL SURVEY FOR THE DEED OF RECORD AS PROVIDED BY CLIENT.
- BEARINGS ARE BASED ON AN ASSUMED BEARING OF S.01°22'44"E. FOR THE WEST RIGHT-OF-WAY THEREOF.
- THIS PARCEL IS IN ZONE "X" AND IS DETERMINED TO BE OUTSIDE THE 500 YEAR FLOOD PLAIN AS PER FLOOD RATE MAP, DATED 6 JANUARY, 1988 COMMUNITY PANEL NUMBER 120070 0225 B. HOWEVER, THE FLOOD INSURANCE RATE MAPS ARE SUBJECT TO CHANGE.
- IF THEY EXIST, NO UNDERGROUND ENCROACHMENTS AND/OR UTILITIES WERE LOCATED FOR THIS SURVEY EXCEPT AS SHOWN HEREON.
- THIS SURVEY WAS COMPLETED WITHOUT THE BENEFIT OF A TITLE COMMITMENT OR A TITLE POLICY.
- EASEMENTS OF (20') TWENTY FEET IN WIDTH ALONG THE ROAD FRONT OF EACH LOT AND (7.5') SEVEN AND ONE-HALF FEET IN WIDTH ALONG EACH SIDE LOT LINES ARE HEREBY CREATED AND PROVIDED FOR THE PURPOSE OF ACCOMMODATING OVERHEAD, SURFACE, AND UNDERGROUND UTILITIES AND DRAINAGE. WHERE AN AREA GREATER THAN ONE LOT IS USED AS A BUILDING SITE, ONLY THE OUTSIDE BOUNDARY OF SAID SITE SHALL BE SUBJECT TO THE LOT LINE EASEMENT.

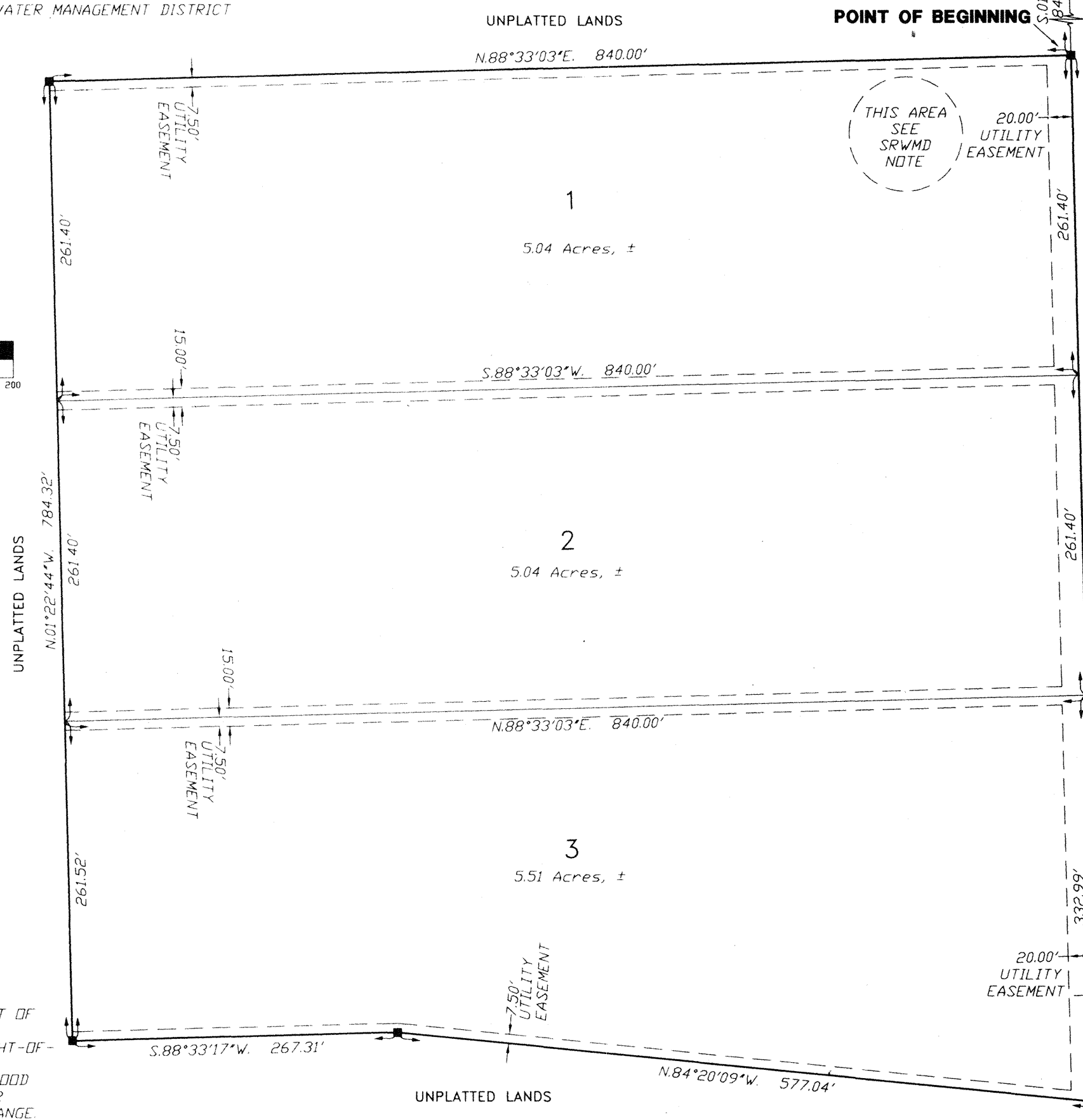
COMMENCE AT THE NE CORNER OF THE SOUTH 1/2 OF SECTION 25, TOWNSHIP 5 SOUTH, RANGE 15 EAST, COLUMBIA COUNTY, FLORIDA, THENCE S.88°33'03"W, ALONG THE NORTH LINE OF SAID SOUTH 1/2, 400.06 FEET TO A POINT ON THE WEST RIGHT-OF-WAY OF ICHETUCKNEE ROAD, THENCE S.01°22'44"E, ALONG SAID WEST RIGHT-OF-WAY LINE, 844.21 FEET TO THE POINT OF BEGINNING; THENCE S.01°22'44"E, 855.79 FEET; THENCE N.84°20'09"W, 577.04 FEET; THENCE S.88°33'17"W, 267.31 FEET; THENCE N.01°22'44"E, 784.32; THENCE N.88°33'03"E, 840.00 FEET TO THE POINT OF BEGINNING, CONTAINING 15.59 ACRES, MORE OR LESS.

THIS SUBDIVISION CONSISTS OF ROLLING TERRAIN WITH SOME DEPRESSIONS AND SINKHOLES. ALTHOUGH, THE FLOOD INSURANCE RATE MAP (FIRM) SHOWS IT TO BE OUTSIDE THE 100 YEAR FLOOD ZONE SOME OF THE LOW AREAS MAY HOLD WATER FOR A SHORT TIME AFTER A RAIN.
