BEGIN at the Southeast corner of the Northwest 1/4 of the Southeast 1/4, Section 20, Township 3 South, Range 16 East, Columbia County, Florida and run N. 89° 29' 57" W. along the South line of said Northwest 1/4 of the Southeast 1/4 a distance of 305.54 feet; thence S. 12° 25' 30.72 feet; thence N. 89° 29' 57" W. 688.26 feet; thence N. 10° 16' 16"E. 30.43 feet to said South line of the Northwest 1/4 of the Southeast 1/4; thence N. 89° 29' 57" W. along said South line 370.85 feet to the Southwest corner of said Northwest 1/4 of the Southeast 1/4, Section 20; thence N. 1° 03' 36" W. along the West line of the Southeast 1/4, Section 20 a distance of 1327.79 feet to the Northwest corner of said Southeast 1/4, (also the Southwest corner of the Northeast 1/4, Section 20); thence continue N. 1° 03' 36" W. along the West line of said Northeast 1/4 a distance of 244.23 feet; thence S. 60° 34' 45"E. 317.81 feet; thence S. 64° 06' 16"E. 245.26 feet; thence S. 62° 23' 55"E. 456.66 feet; thence S. 72° 47' 19"E. 504.13 feet to the East line of said Northwest 1/4 of the Southeast 1/4, Section 20; thence S. 0° 40' 02"E. along said East line 959.78 feet to the POINT OF BEGINNING.
