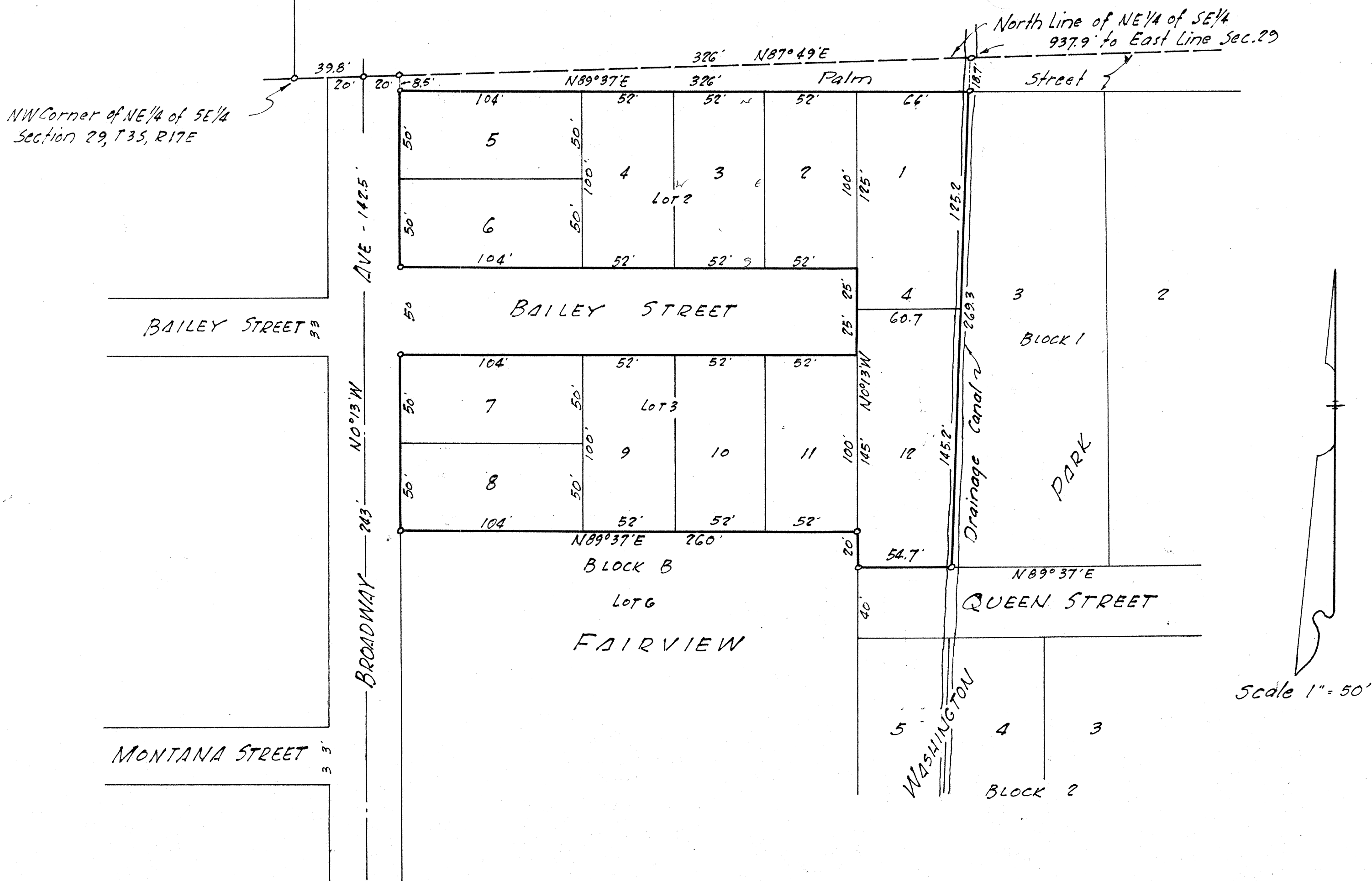


# FINLEY'S ADDITION
