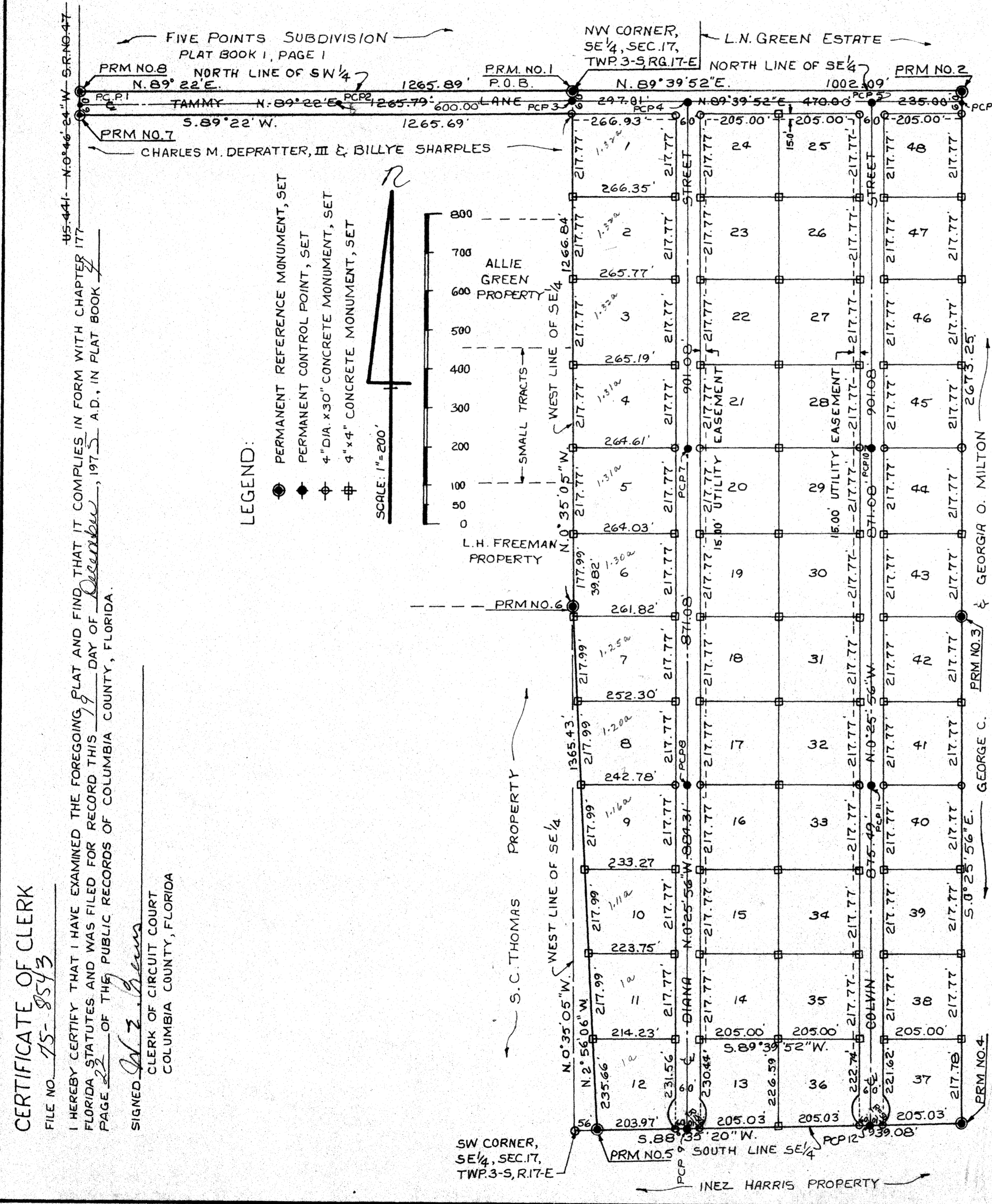

BEGINNING AT THE NORTHEAST CORNER OF THE SOUTHEAST ONE-QUARTER (SE 1/4), SECTION 17, TOWNSHIP 3-SOUTH, RANGE 17-EAST, AND RUN THENCE N. 89° 39' 52" E., ALONG THE NORTH LINE OF SAID SOUTHEAST ONE-QUARTER (SE 1/4), 1002.09 FEET, THENCE S. 0° 25' 56" E., 2673.25 FEET, TO THE SOUTH LINE OF SAID SOUTHEAST ONE-QUARTER (SE 1/4), THENCE S. 88° 35' 20" W., ALONG SAID SOUTH LINE, 939.08 FEET, THENCE N. 2° 56' 06" W., 15.43 FEET, TO THE WEST LINE OF SAID SOUTHEAST ONE-QUARTER (SE 1/4), THENCE N. 0° 35' 05" W., ALONG SAID WEST LINE, 1266.84 FEET, THENCE S. 89° 22' W., 1265.69 FEET, TO THE EAST RIGHT-OF-WAY LINE OF STATE ROAD NO. 47 (U.S. HIGHWAY NO. 441), THENCE N. 0° 46' W., ALONG SAID EAST RIGHT-OF-WAY LINE OF STATE ROAD NO. 47, TO THE POINT-OF-INTERSECTION OF SAID EAST RIGHT-OF-WAY LINE WITH THE NORTH LINE OF THE SOUTHWEST ONE-QUARTER (SW 1/4) OF SAID SECTION, THENCE N. 89° 22' E., ALONG THE NORTH LINE OF SAID SOUTHWEST ONE-QUARTER (SW 1/4), 1265.89 FEET TO THE POINT-OF-BEGINNING.
