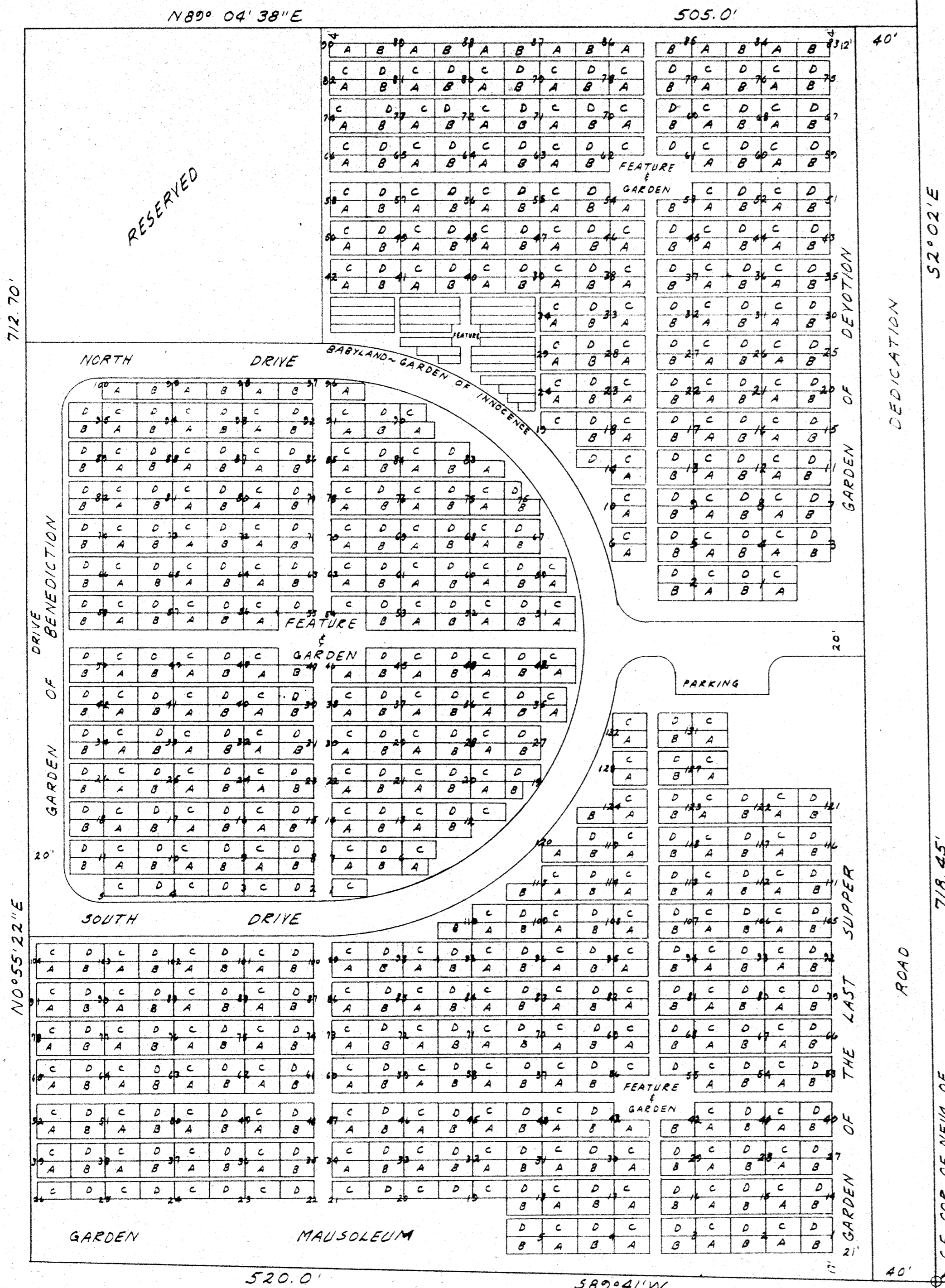

 BEGIN AT THE SOUTHEAST CORNER OF NE1/4 OF SW1/4, SECTION 17, TOWNSHIP 4 SOUTH, RANGE 17 EAST, COLUMBIA COUNTY, FLORIDA, AND RUN THENCE S89° 41' W, ALONG THE SOUTH LINE OF SAID NE1/4 OF SW1/4, 520.0 FEET, THENCE RUN N0° 55' 22\" E, 712.70 FEET, TO THE NORTH LINE OF THE 5/12, OF N1/2 OF SAID SW1/4, THENCE RUN N89° 04' 38\" E, ALONG SAID NORTH LINE 505.0 FEET, TO THE EAST LINE OF SAID NE1/4 OF SW1/4, THENCE RUN S2° 02' E ALONG SAID EAST LINE 718.45 FEET TO THE POINT OF BEGINNING.

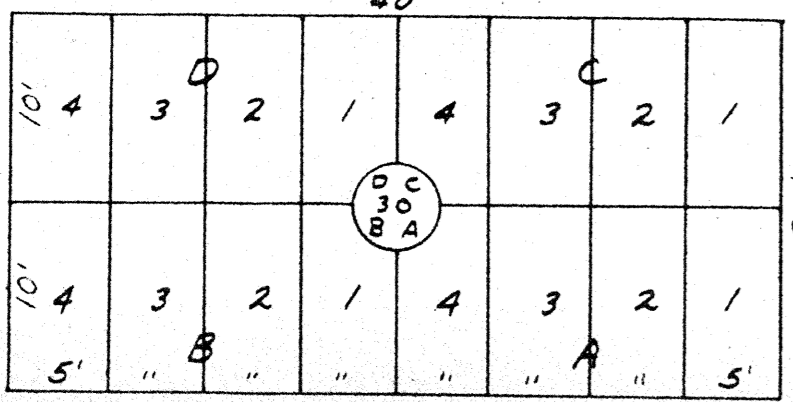
