





# LEGAL DESCRIPTION

Begin at the northeast corner of the northwest 1/4 of Section 3, Township 7 South, Range 16 East, Columbia County, Florida and run thence South 03°01'01" West, along the east line of said northwest 1/4, 1145.33 feet to the easterly right-of-way line of State Road No. 20 (US Hwy 27); thence North 44°38'44" West, along said easterly right-of-way line 1688.10 feet to the north line of said Section 3 (being also the south line of Section 34, Township 6 South, Range 16 East); thence South 87°22'18" East, along said south line of Section 34, 260.79 feet; thence North 03°16'33" East, 441.05 feet; thence South 87°22'18" East, 988.32 feet to the east line of the southwest 1/4 of said Section 34; thence South 03°26'55" West, along said east line 441.07 feet to the POINT OF BEGINNING. Said lands being a part of the northeast 1/4 of Northwest 1/4 of Section 3, Township 7 South, Range 16 East and a part of the southeast 1/4 of southwest 1/4, Section 34, Township 6 South, Range 16 East.
