BLOCKS 22, 27, 34 AND THE WEST 1/3 OF 23, 26 AND 35 OF McELROY'S SUBDIVISION OF THE S.W. 1/4 OF SECTION 29, TOWNSHIP 3-SOUTH, RANGE 17-EAST, COLUMBIA COUNTY, FLORIDA MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGIN AT A POINT ON THE SOUTH LINE OF SAID S.W. 1/4 OF NE 1/4 342 FEET WEST OF THE S.E. CORNER AND RUN THENCE N. 0° 41' W. 180.6 FEET, THENCE S. 87° 32' W. 313 FEET, THENCE S. 0° 41' E. 179.74 FEET, THENCE N. 87° 49' E. 313 FEET TO POINT OF BEGINNING

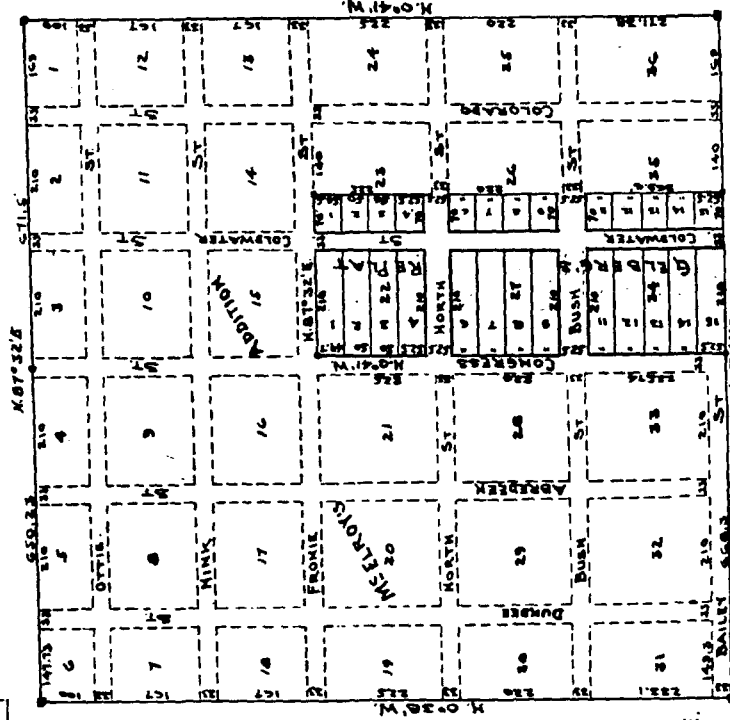
