FEET, THENCE SOUTH 7° 0' WEST 294.80 FEET,
THENCE NORTH 88° 58' WEST 298.00 FEET TO
SAID ERMINIE STREET, THENCE NORTH 7° 0'
EAST 294.80 FEET TO POINT OF BEGINNING.


