COMMENCE at the Southeast corner of the Southwest 1/4 of Section 7, Township 5 South, Range 16 East, Columbia County, Florida and run N.00°23'39"W. along the East line of said Southwest 1/4 a distance of 40.00 feet to a point on the Northerly Right-of-Way line of County Road No. C-240; thence S.89°10'10"W. along said Northerly Right-of-Way line 60.42 feet to a point on the Westerly Right-of-way line of Boyette Lane; thence N.00°59'33"W. along said Westerly Right-of-Way line 275.00 feet to the Southeast corner of Lot #7 of "SOUTH COLUMBIA ACRES" a subdivision as recorded in the official records of Columbia County, Florida; thence S.89°10'10"W. along the South line of said Lot #7 a distance of 300.00 feet to the POINT OF BEGINNING; thence continue S.89°10'10"W. along the North line of a part of said "SOUTH COLUMBIA ACRES" 889.06 feet; thence N.00°23'39"W. 2334.58 feet to a point on the North line of the Southwest 1/4 of said Section 7; thence N.89°12'38"E. along said North line 751.18 feet to a point on the West line of said "SOUTH COLUMBIA ACRES"; thence S.00°23'38"E. along said West line 150.00 feet; thence S.20°28'29"E. still along said West line 345.00 feet; thence S.00°59'33"E. still along said West line 1859.07 feet to the POINT OF BEGINNING. 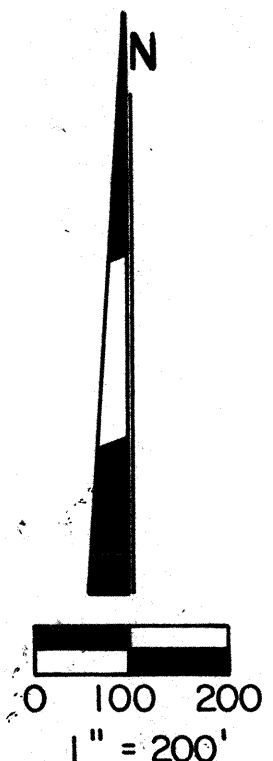
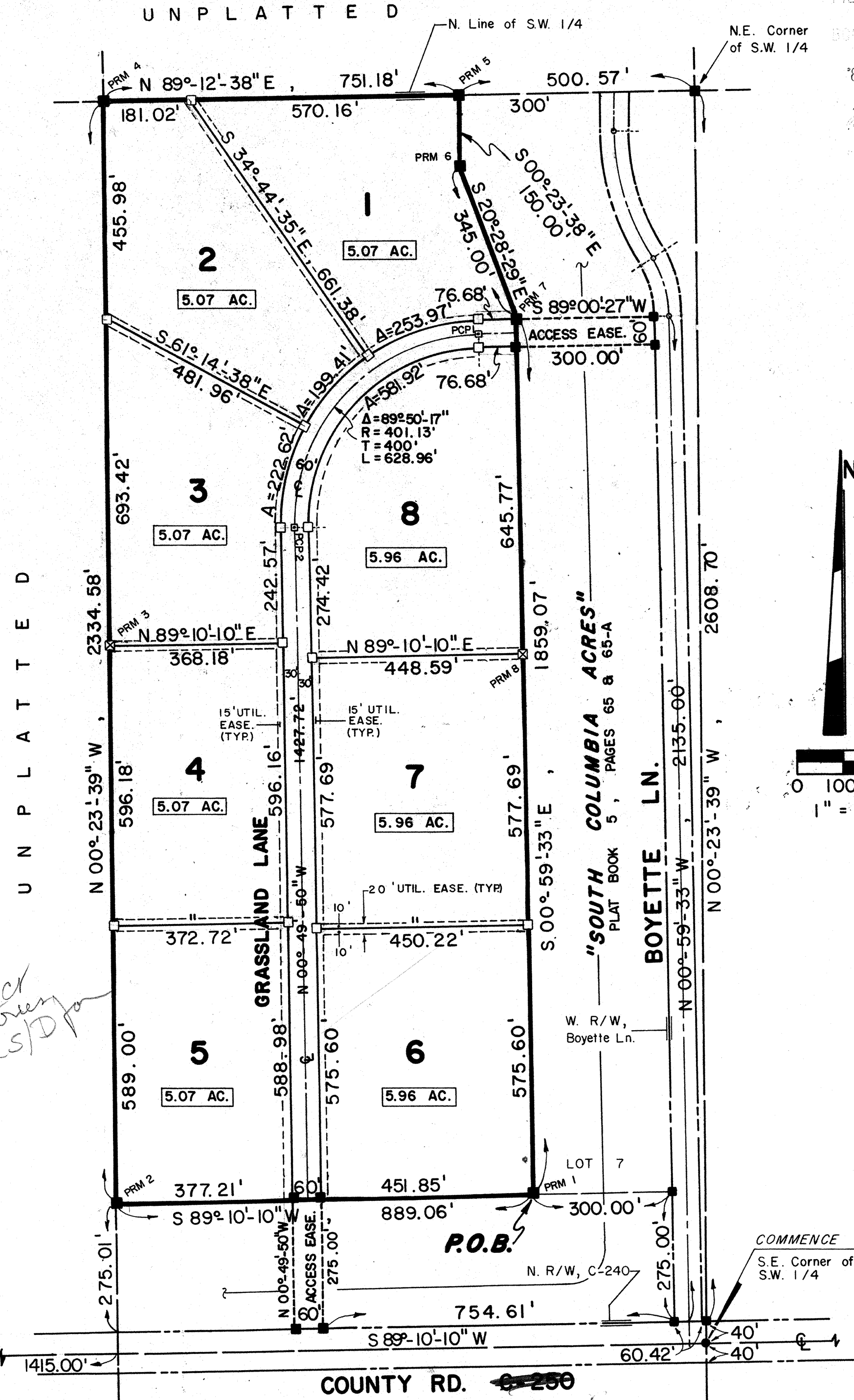
