COMMENCE AT THE NORTHWEST CORNER OF THE N.E. 1/4 OF N.E. 1/4, SECTION 26, TWS. 4, SOUTH, RANGE 16 EAST AND RUN S. 1° 55' 30" E. 40.03 FEET TO THE SOUTH RIGHT OF WAY LINE OF STATE ROAD NO. S-242; THENCE CONTINUE S. 1° 55' 30" E. 210.0 FT. TO A POINT ON THE WEST LINE OF SAID N.E. 1/4 OF N.E. 1/4 AND TO THE POINT OF BEGINNING AND RUN THENCE S. 89° 48' 24" E. 210.0 FT.; THENCE N. 1° 55' 30" W. 210.0 FT. TO SAID RIGHT OF WAY LINE; THENCE S. 89° 48' 24" E. ALONG SAID RIGHT OF WAY LINE 128.86 FT. TO THE POINT OF CURVE OF SAID RIGHT OF WAY LINE; THENCE EASTERLY ALONG SAID CURVE, WITH A RADIUS OF 1392.40 FT. AN ARC DISTANCE OF 1093.59 FT.
