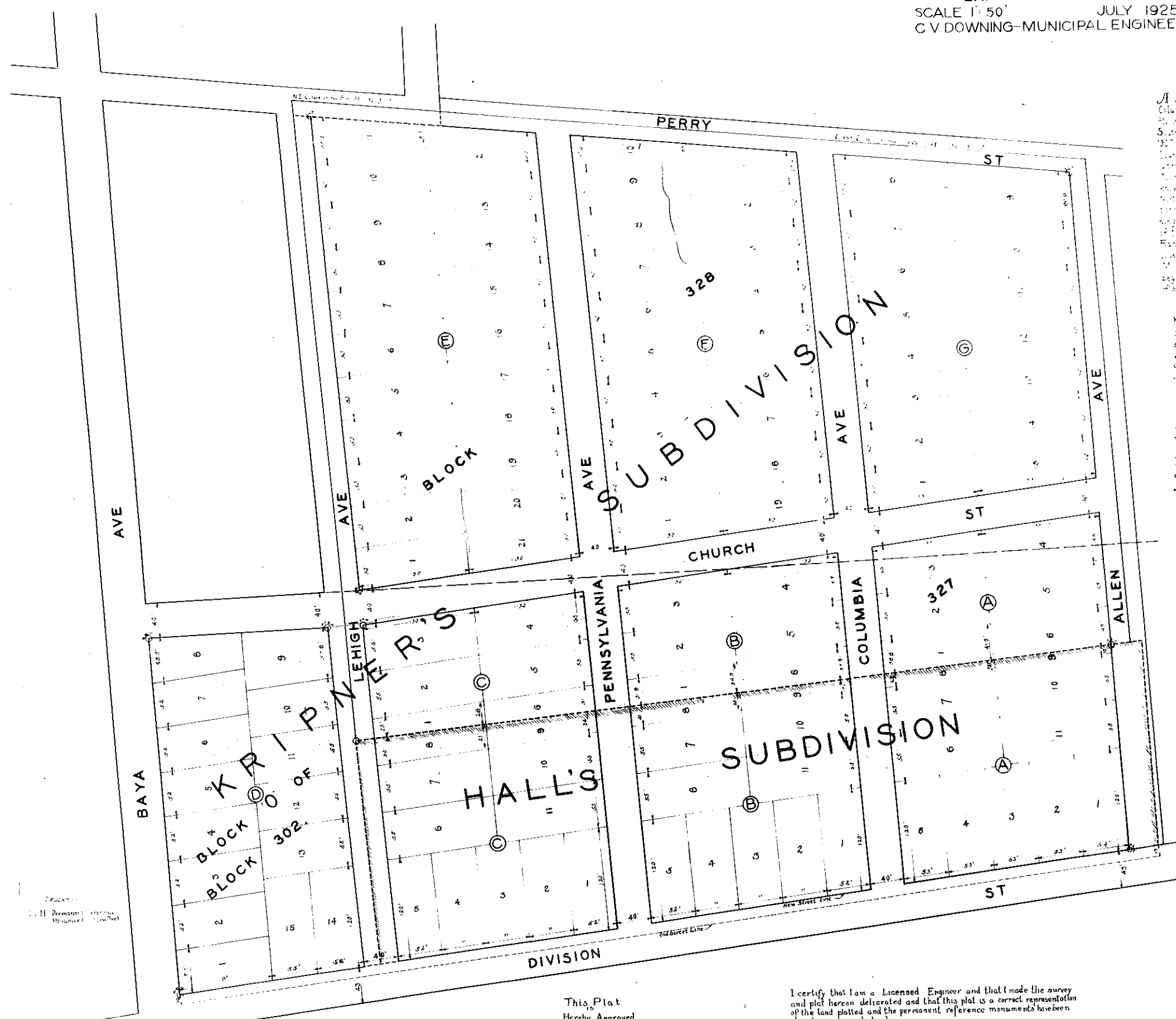


MAP

KRIPNER'S SUBDIVISION
 Description of Tract

A subdivision of certain land lying and being in Lake City, Columbia County, Florida, and more particularly described as follows: Beginning at a point on the East line of Division Street, thence East thirty-five feet to the East line of Perry Street, thence South thirty-five feet to the East line of Church Street, thence East thirty-five feet to the East line of Pennsylvania Avenue, thence South thirty-five feet to the East line of Columbia Avenue, thence East thirty-five feet to the East line of Allen Avenue, thence South thirty-five feet to the East line of Division Street, thence in a Northerly direction along the East line of said Division Street one hundred and thirty feet to a stake, thence South ninety feet to the point of beginning, and containing 0.80 acres, according to survey of said tract made by C. V. Downing on April 1, 1925.

A subdivision of certain land lying and being in Lot 327 of the southern division of Lake City, Columbia County, Florida, and more particularly described as follows: Beginning at a point on the East line of Division Street, thence East thirty-five feet to the East line of Church Street, thence East thirty-five feet to the East line of Pennsylvania Avenue, thence South thirty-five feet to the East line of Columbia Avenue, thence East thirty-five feet to the East line of Allen Avenue, thence South thirty-five feet to the East line of Division Street, thence in a Northerly direction along the East line of said Division Street one hundred and thirty feet to a stake, thence South ninety feet to the point of beginning, and containing 0.80 acres, according to survey of said tract made by C. V. Downing on April 1, 1925.
