Begin at the SW Cor. Section 30, Township 3 South, Range 17 East and Run North 0°05'W Along West Line of Said Section 30 a Distance of 602.68 Feet to a Point, Thence North 88°56'30"E a Distance of 946.13 Feet to a Point, Thence South 0°14'E a Distance of 576.60 Feet to a Point on North Right of Way Line Hillsboro Street in Holiday Heights Subdivision, Thence South 88°52'30"W Along Said North Line Hillsboro Street a Distance of 2382.6 Feet to the North West Corner Holiday Heights; Thence South 0°56'W Along West Line Holiday Heights a Distance of 84.51 Feet to a Point on South Line Said Section 30, Thence South 0°56'W Along West Line Holiday Heights a Distance of 471.19 Feet to a Point, Thence South 88°36'W a Distance of 700.48 Feet to a Point on the West Line of Section 31 Township 3 South, Range 17 East; Thence North 0°01'E Along Said West Line Section 31 a Distance of 473.88 Feet to the Point of Beginning. Contains 2155 Acres More or Less.
