CORNER OF SEC. 19 T7S R16E COLUMBIA COUNTY, FLORIDA, RUN THENCE  $50^{\circ}57'W$  ALONG THE EAST LINE OF SAID SEC. 19  $1046' \pm$  TO THE WATERS EDGE OF THE SANTA FE RIVER, RUN THENCE NORTHWESTERLY ALONG THE WATERS EDGE OF THE SANTA FE RIVER  $1588.71' \pm$  TO THE NORTH LINE OF SECTION 19 T7S R16E, RUN THENCE  $S88^{\circ}37'E$  ALONG SAID NORTH LINE  $1122' \pm$  TO THE P.O.B.

ALL BEING AND LYING IN THE N.E. 1/4 OF SECTION 19 T7S R16E COLUMBIA COUNTY, FLORIDA.

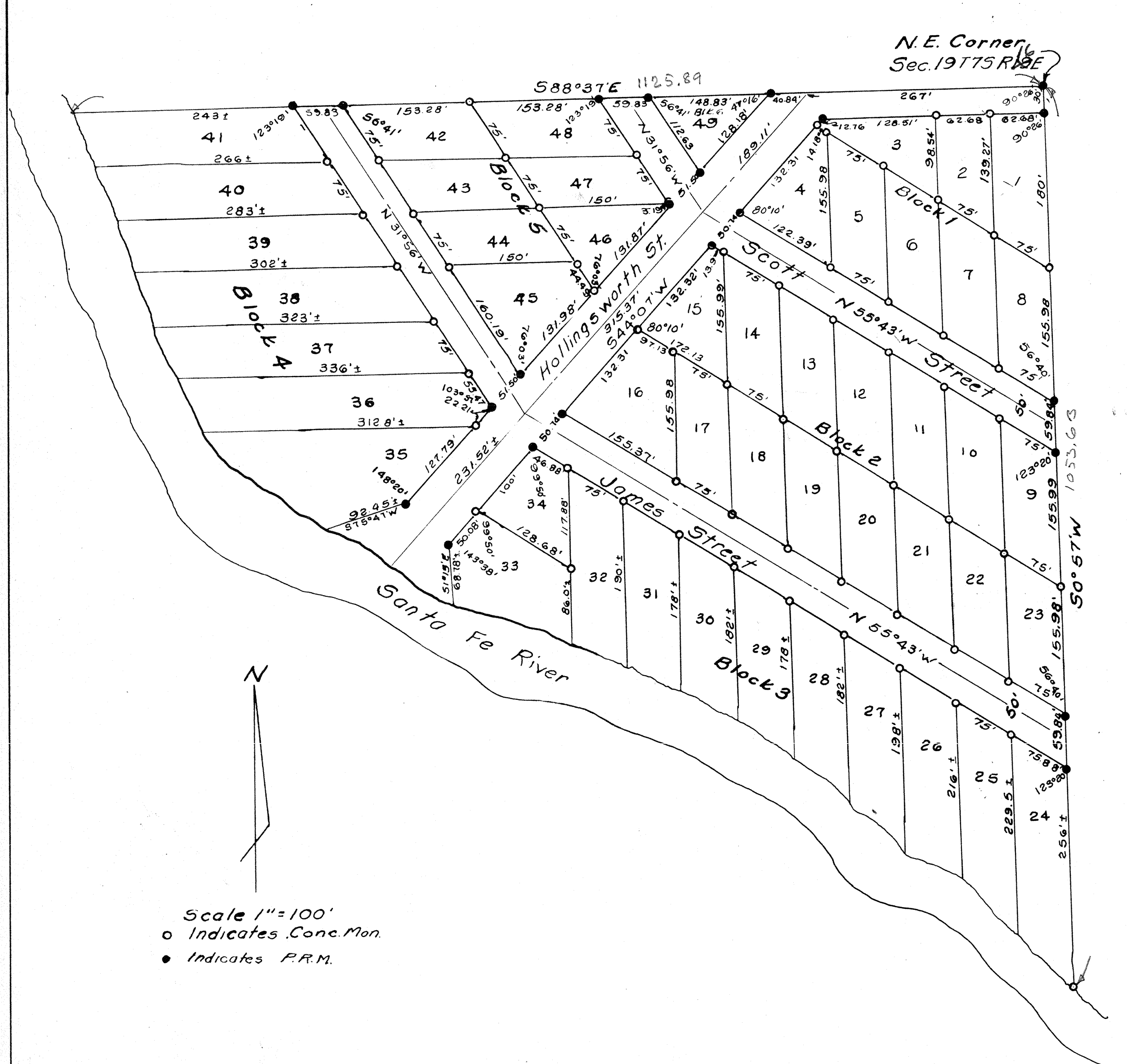
