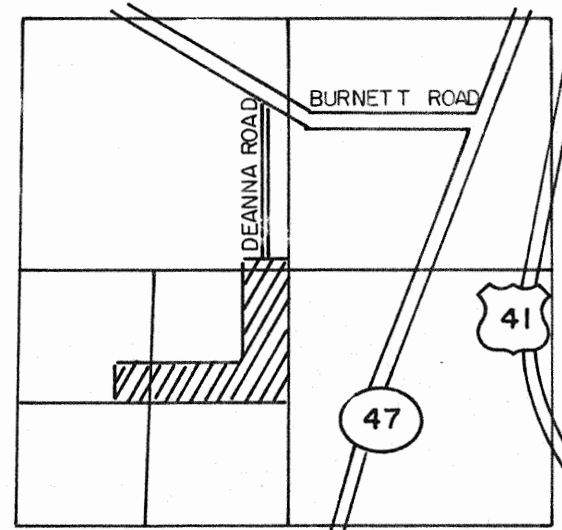


DESCRIPTION:

A PART OF THE WEST 1/2 OF SECTION 7, TOWNSHIP 4 SOUTH, RANGE 17 EAST, MORE PARTICULARLY DESCRIBED AS FOLLOWS; BEGIN AT THE NORTHEAST CORNER OF THE SW 1/4 OF SAID SECTION 7 AND RUN S 2°23'52"E, ALONG THE EAST LINE THEREOF, 1326.26 FEET TO THE SOUTHEAST CORNER OF THE NE 1/4 OF THE SW 1/4 OF SAID SECTION 7; SAID POINT BEING ALSO ON THE NORTH LINE OF COUNTRY VILLAGE, AS RECORDED IN PLAT BOOK 4 PAGE 103 OF THE PUBLIC RECORDS OF COLUMBIA COUNTY, FLORIDA; THENCE S 85°21'09" W, ALONG THE SOUTH LINE OF THE NE 1/4 OF THE SW 1/4 OF SAID SECTION 7, A DISTANCE OF 1371.97 FEET TO THE SOUTHWEST CORNER OF THE NE 1/4 OF THE SW 1/4 OF SAID SECTION 7, THENCE S 85°22'32" W, ALONG THE SOUTH LINE OF THE NW 1/4 OF THE SW 1/4 OF SAID SECTION 7, SAID LINE BEING ALSO THE NORTH LINE OF LOT-1 OF COUNTRY LANDING AS RECORDED IN PLAT BOOK 6 PAGE 90 OF THE PUBLIC RECORDS OF COLUMBIA COUNTY, FLORIDA, 125.26 FEET TO A POINT ON THE EAST RIGHT-OF-WAY LINE OF DEANNA ROAD AS RECORDED IN OFFICIAL RECORDS BOOK 767 PAGE 802 OF THE PUBLIC RECORDS OF COLUMBIA COUNTY, FLORIDA; THENCE N 0°34'19" W, ALONG SAID EAST RIGHT-OF-WAY LINE, 189.59 FEET TO ITS INTERSECTION WITH THE SOUTH RIGHT-OF-WAY LINE OF SAID DEANNA ROAD; THENCE N 86°03'38" E, ALONG SAID SOUTH RIGHT-OF-WAY LINE, 151.89 FEET; THENCE N 86°11'33" E, 588.97 FEET TO A POINT OF CURVE OF A CURVE TO THE LEFT, HAVING A RADIUS OF 630.00 FEET AND AN INCLUDED ANGLE OF 6°12'27"; THENCE NORTHEASTERLY ALONG THE ARC OF SAID CURVE AN ARC DISTANCE OF 68.26 FEET; THENCE N 79°59'06" E, 490.78 FEET TO ITS INTERSECTION WITH THE EAST RIGHT-OF-WAY LINE OF SAID DEANNA ROAD; THENCE N 1°22'53" W, ALONG SAID EASTERLY RIGHT-OF-WAY LINE, 922.83 FEET TO A POINT OF CURVE OF A CURVE TO THE LEFT, HAVING A RADIUS OF 630.00 FEET AND AN INCLUDED ANGLE OF 4°01'04"; THENCE NORTHWESTERLY ALONG THE ARC OF SAID CURVE, AN ARC DISTANCE OF 44.18 FEET; THENCE N 5°23'57" W, 186.29 FEET; THENCE S 84°36'03" W, 60.00 FEET TO A POINT ON THE WESTERLY RIGHT-OF-WAY LINE OF SAID DEANNA ROAD; THENCE S 5°23'57" E, ALONG SAID WESTERLY RIGHT-OF-WAY LINE 186.29 FEET TO THE POINT OF CURVE OF A CURVE TO THE RIGHT, HAVING A RADIUS OF 570.00 FEET AND AN INCLUDED ANGLE OF 4°01'04"; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE, AN ARC DISTANCE OF 39.97 FEET; THENCE S 1°22'53" E, 871.25 FEET TO ITS INTERSECTION WITH THE NORTH RIGHT-OF-WAY LINE OF SAID DEANNA ROAD; THENCE S 79°59'06" W, ALONG SAID NORTH RIGHT-OF-WAY LINE, 439.20 FEET TO THE POINT OF CURVE OF A CURVE TO THE RIGHT, HAVING A RADIUS OF 570.00 FEET AND AN INCLUDED ANGLE OF 6°12'27"; THENCE SOUTHWESTERLY ALONG THE ARC OF SAID CURVE, AN ARC DISTANCE OF 61.75 FEET; THENCE S 86°11'33" W, 589.05 FEET; THENCE S 86°03'38" W, 208.54 FEET TO ITS INTERSECTION WITH THE WEST RIGHT-OF-WAY LINE OF SAID DEANNA ROAD; THENCE S 0°34'19" E, ALONG SAID WEST RIGHT-OF-WAY LINE, 250.41 FEET TO THE NORTHEAST CORNER OF LOT-2 OF SAID COUNTRY LANDING; THENCE S 85°22'32" W, ALONG THE NORTH LINE THEREOF, 125.00 FEET; THENCE N 0°36'08" W, 191.82 FEET; THENCE N 86°03'38" E, 98.49 FEET TO THE POINT OF CURVE OF A CURVE TO THE RIGHT, HAVING A RADIUS OF 25.00 FEET, AND AN INCLUDED ANGLE OF 93°22'03"; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE, AN ARC DISTANCE OF 40.74 FEET TO A POINT ON THE WEST RIGHT-OF-WAY LINE OF SAID DEANNA ROAD; THENCE N 0°34'19" W, ALONG SAID WEST LINE, 86.61 FEET; THENCE S 86°03'38" W, 67.25 FEET; THENCE N 1°22'53" W, 149.61 FEET; THENCE N 86°11'33" E, 882.00 FEET; THENCE N 83°00'33" E, 308.30 FEET; THENCE N 1°22'53" W, 134.02 FEET; THENCE N 86°03'46" E, 145.68 FEET TO THE POINT OF CURVE OF A CURVE TO THE RIGHT, HAVING A RADIUS OF 25.00 FEET AND AN INCLUDED ANGLE OF 92°33'19"; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE, AN ARC DISTANCE OF 40.38 FEET TO A POINT ON THE WEST RIGHT-OF-WAY LINE OF SAID DEANNA ROAD; THENCE N 1°22'53" W, ALONG SAID WEST LINE 110.00 FEET TO THE POINT OF CURVE OF A CURVE TO THE RIGHT, HAVING A RADIUS OF 25.00 FEET AND AN INCLUDED ANGLE OF 87°26'41"; THENCE SOUTHWESTERLY ALONG THE ARC OF SAID CURVE, AN ARC DISTANCE OF 38.16 FEET; THENCE S 86°03'46" W, 91.20 FEET; THENCE N 1°22'53" W, 225.13 FEET; THENCE S 88°37'07" W, 85.00 FEET; THENCE N 1°22'53" W, 561.80 FEET; THENCE N 84°36'03" E, 185.43 FEET TO A POINT ON THE WESTERLY RIGHT-OF-WAY LINE OF SAID DEANNA ROAD; SAID POINT BEING ON A CURVE CONCAVE TO THE SOUTH WEST; SAID CURVE HAVING A RADIUS OF 570.00 FEET AND AN INCLUDED ANGLE OF 0°45'09"; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE, AN ARC DISTANCE OF 7.49 FEET; THENCE N 84°36'03" E, 251.02 FEET TO A POINT ON THE WEST LINE OF LOT-10 OF EDGEWOOD ESTATES AS RECORDED IN PLAT BOOK 4 PAGE 44 OF THE PUBLIC RECORDS OF COLUMBIA COUNTY, FLORIDA, THENCE S 0°42'33" E, ALONG THE WEST LINE THEREOF, 56.40 FEET TO THE POINT OF BEGINNING. COLUMBIA COUNTY, FLORIDA. CONTAINING 20.36 ACRES, MORE OR LESS.

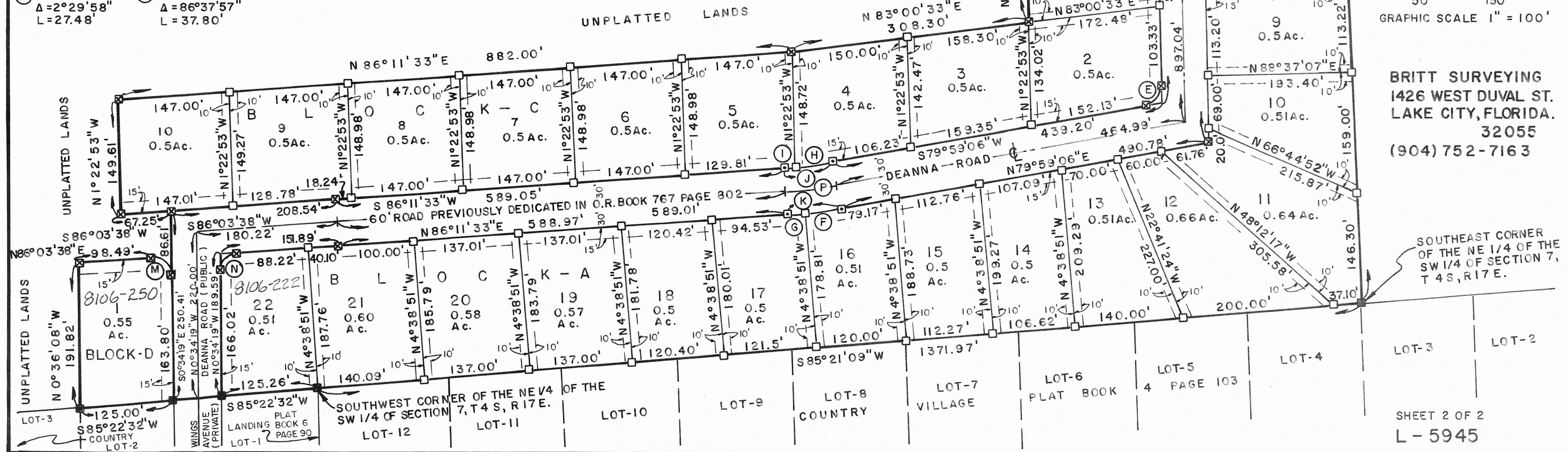

LOCATION SKETCH NOT TO SCALE SECTION 7, T4S, R17E.

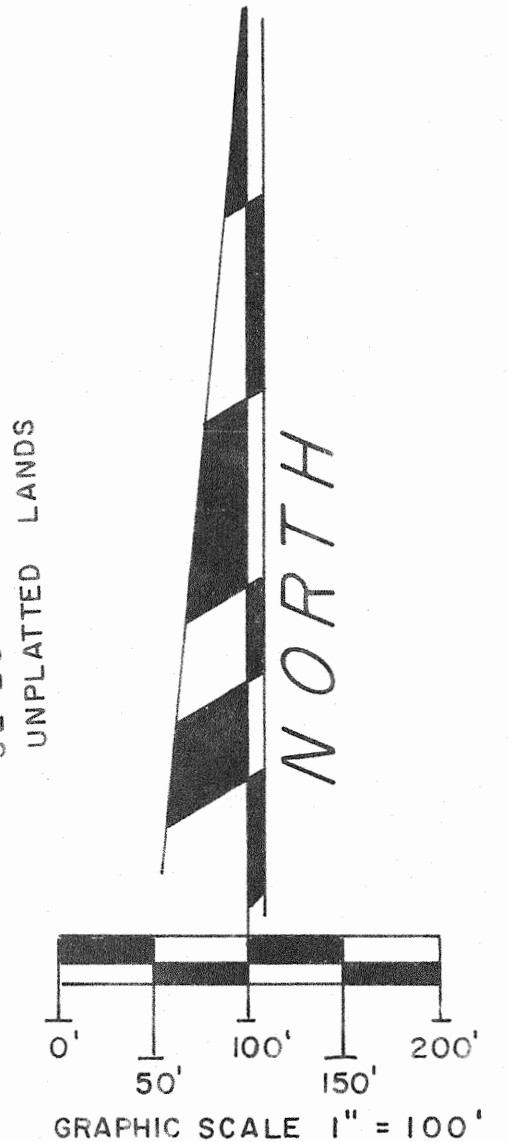

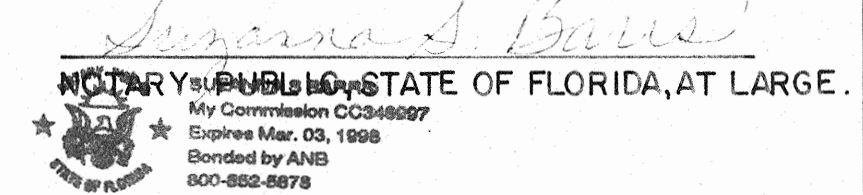
