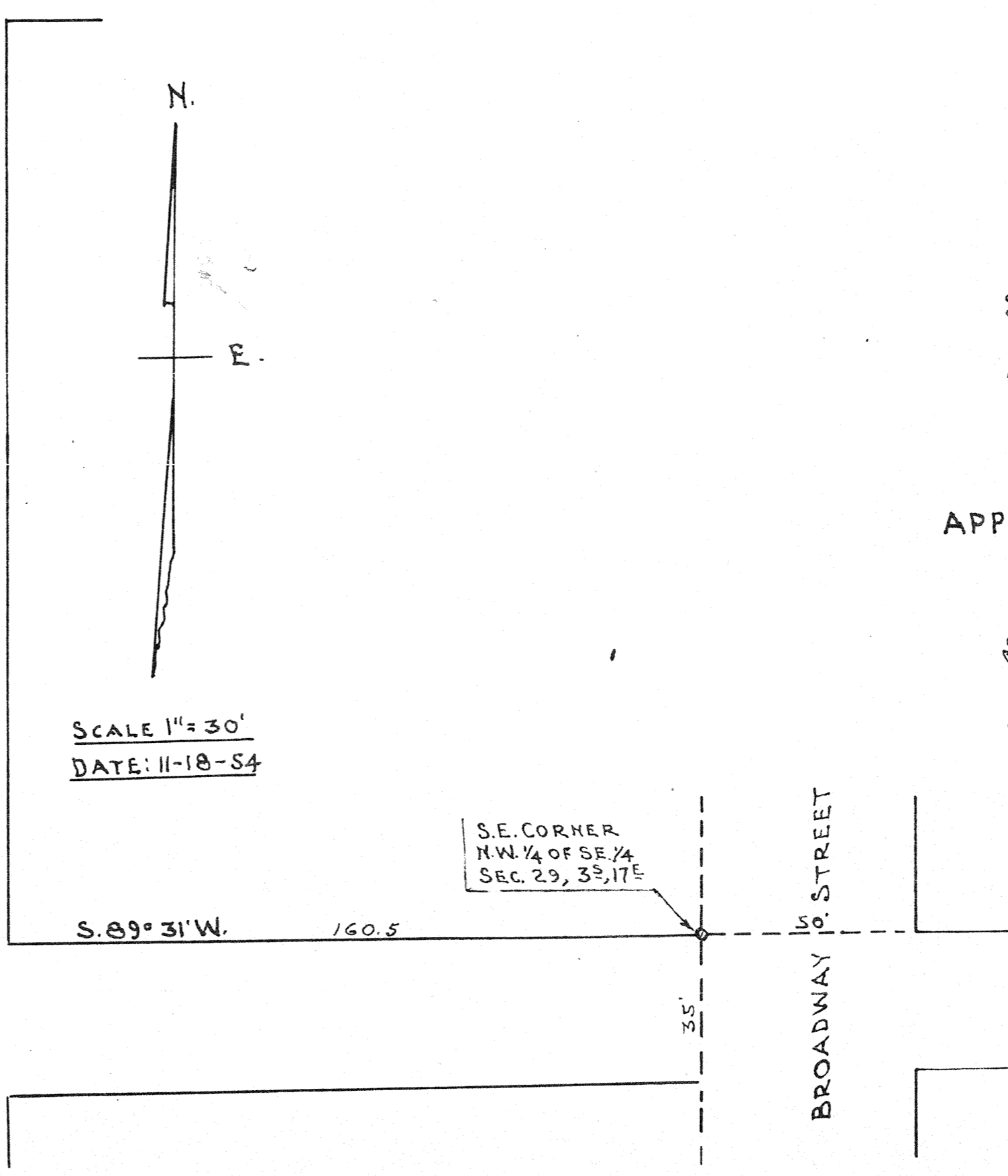
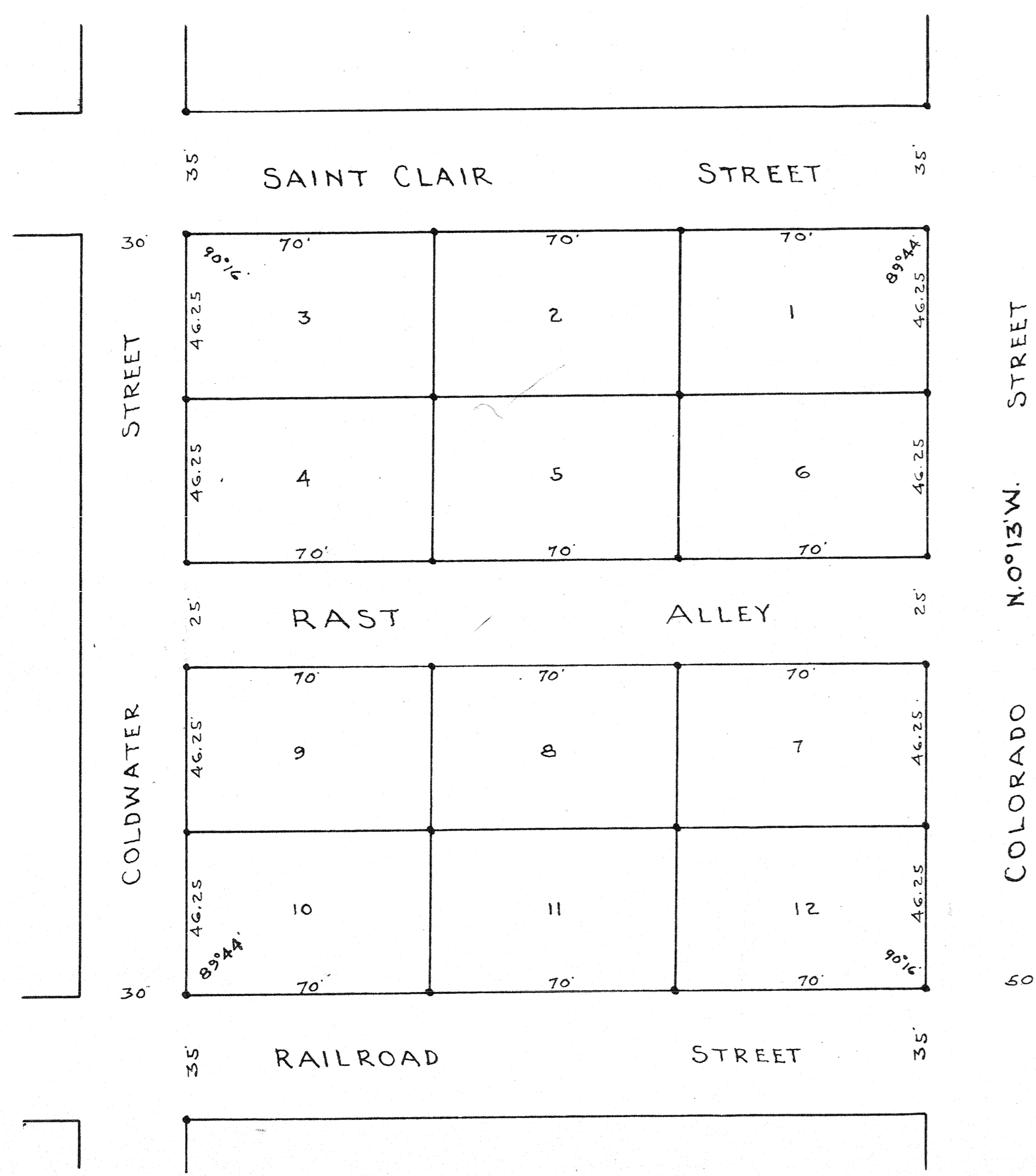
DESCRIPTION

COMMENCE AT THE S.E. CORNER OF THE N.W. 1/4 OF S.E. 1/4, SECTION 29, TWS. 3-SOUTH, RANGE 17-EAST, COLUMBIA COUNTY, FLORIDA AND RUN S. 89° 31' W, ALONG THE NORTH LINE OF RAILROAD STREET, 210.5 FEET FOR A POINT OF BEGINNING AND RUN S. 89° 31' W, 210 FEET TO THE EAST LINE OF COLDWATER STREET; THENCE N. 0° 13' W, ALONG THE EAST LINE OF COLDWATER STREET, 210 FEET TO THE SOUTH LINE OF SAINT CLAIR STREET; THENCE N. 89° 31' E, ALONG THE SOUTH LINE OF SAINT CLAIR STREET, 210 FEET TO THE WEST LINE OF COLORADO STREET; THENCE S. 0° 13' E, 210 FEET TO POINT OF BEGINNING; BEING BLOCK 10 OF THE NORTHEASTERN DIVISION OF THE CITY OF LAKE CITY, FLORIDA.
