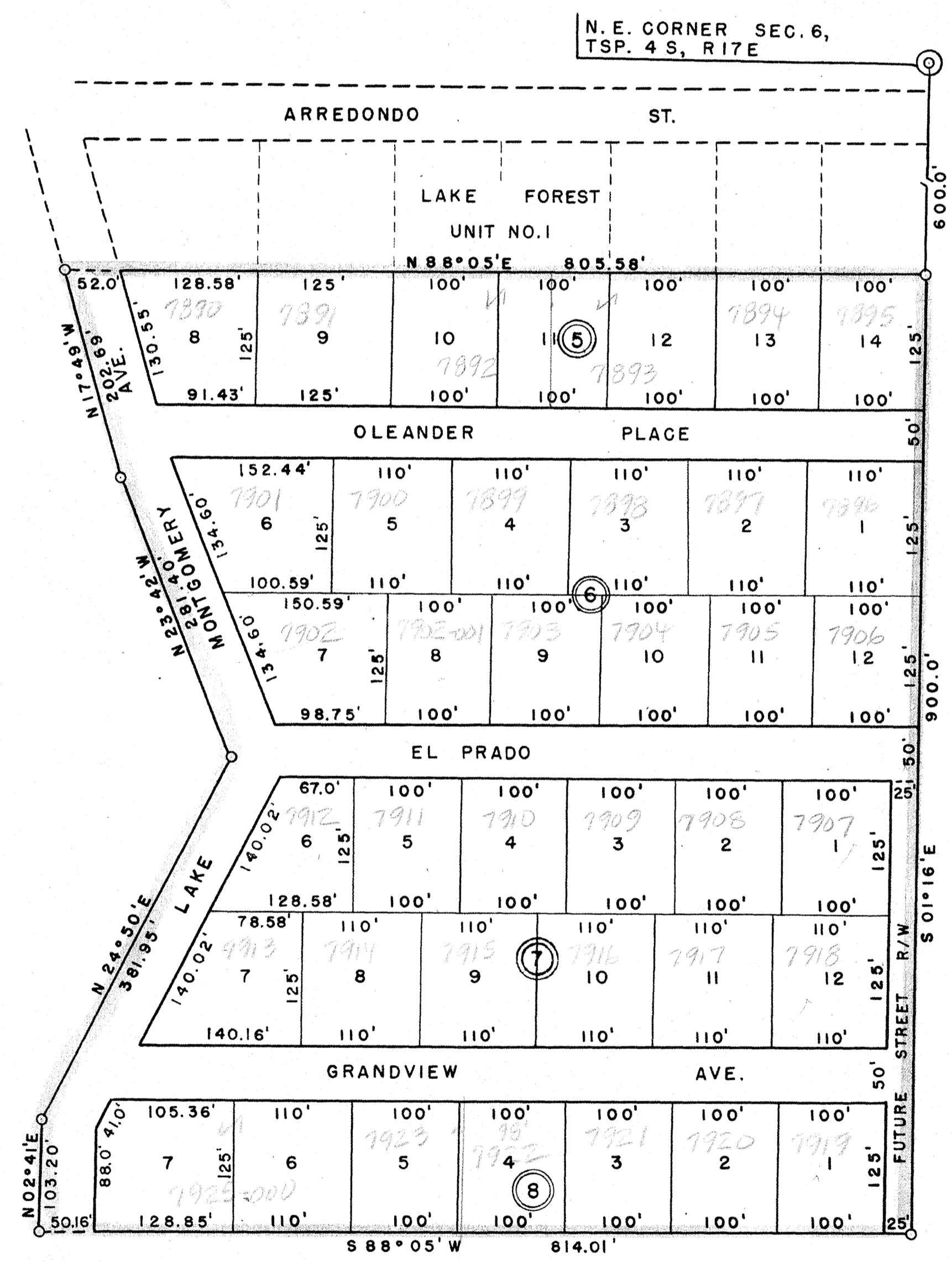

A SUBDIVISION OF A PART OF THE N.E. 1/4 OF THE N.E. 1/4 AND THE S.E. 1/4 OF THE N.E. 1/4, SECTION 6, TSP. 4 SOUTH, RANGE 17 EAST

## UNIT NO. 3



### DESCRIPTION:

COMMENCE AT THE N.E. CORNER OF SEC. 6, TSP. 4 S, R17 E AND RUN THENCE S 01°16' E ALONG THE EAST LINE OF SAID SEC. 6, 600.0 FEET TO THE S.E. CORNER OF LAKE FOREST SUBDIVISION, UNIT NO. 1, AS RECORDED IN PLAT BOOK 3, PAGE 51 OF THE PUBLIC RECORDS OF COLUMBIA COUNTY, FLORIDA, FOR A POINT OF BEGINNING, THENCE CONTINUE S 01°16' E ALONG SAID EAST LINE, 900.0 FEET, THENCE RUN S 88°05' W, PARALLEL TO THE SOUTH LINE OF SAID LAKE FOREST S/D, UNIT NO. 1, 814.01 FEET, THENCE RUN N 02°41' E, 103.20 FEET, THENCE RUN N 24°50' E, 381.95 FEET, THENCE RUN N 23°42' W, 281.40 FEET, THENCE RUN N 17°49' W, 202.69 FEET TO THE SAID SOUTH LINE OF LAKE FOREST S/D, UNIT NO. 1, THENCE RUN N 88°05' E ALONG SAID SOUTH LINE, 805.58 FEET TO THE POINT OF BEGINNING.
