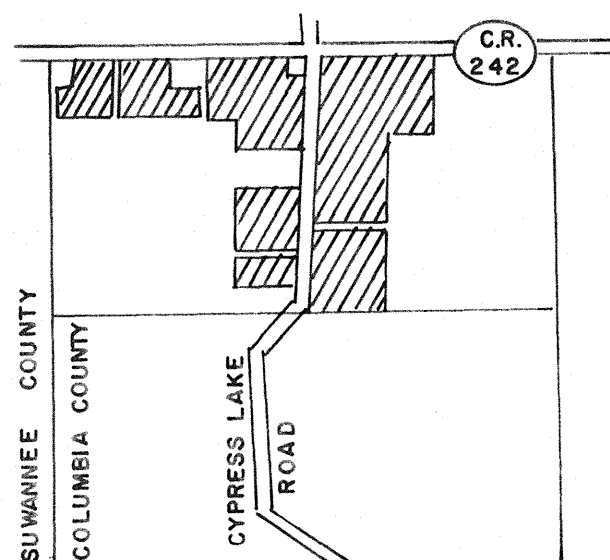
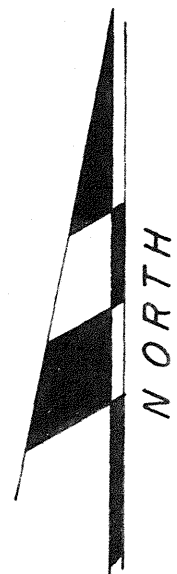
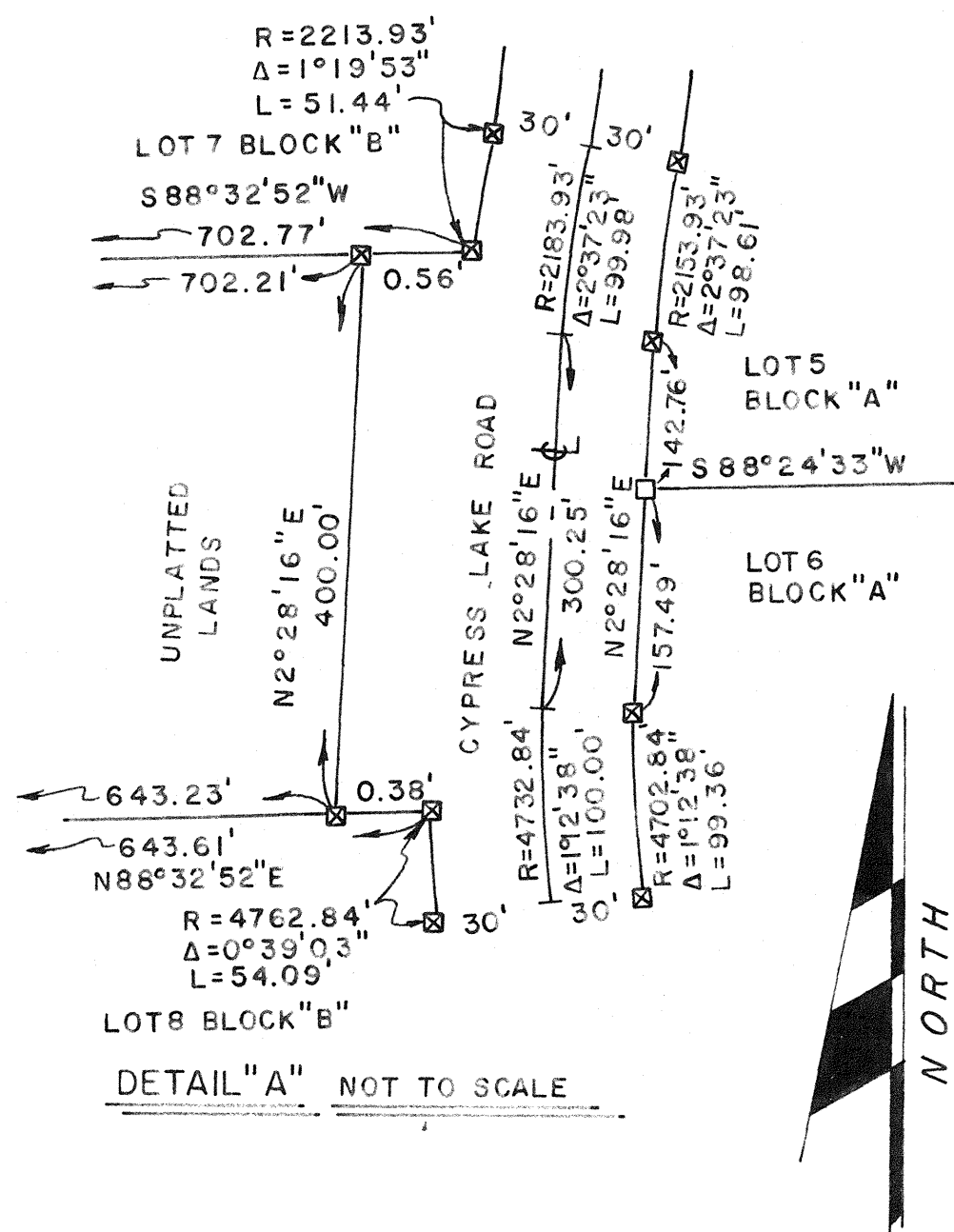


"LANGTREE"

SURVEYOR'S NOTES

1. PRELIMINARY PLAN APPROVED ON 19 NOVEMBER 1992.
2. CLOSURE IS 1:265,000.
3. ALL UTILITY EASEMENTS SHOWN ON THIS PLAT SHALL BE FOR THE CONSTRUCTION, INSTALLATION, MAINTENANCE, AND THE OPERATION OF ELECTRIC, TELEPHONE, GAS, CABLE T.V., AND ANY OTHER PUBLIC UTILITY.
4. THERE MAY BE ADDITIONAL RESTRICTIONS THAT ARE NOT RECORDED ON THIS PLAT THAT MAY BE FOUND IN THE PUBLIC RECORDS OF THIS COUNTY.
5. FLOOD ELEVATION IS DETERMINED BY ARTHUR BODENBRAUGH, P.E. NO. 9162, AND BASED ON D.O.T. DATUM, PROJECT NO. 29641-3602.
6. THE LOWEST STRUCTURAL MEMBER OF THE FIRST FLOOR OF HABITABLE BUILDINGS SHOULD BE AT LEAST ONE FOOT ABOVE THE 100 YEAR FLOOD ELEVATION.
