


Northside Estates

COMMENCE AT THE NORTHWEST CORNER OF THE SOUTHEAST ONE QUARTER (SEL) OF SECTION 30, TOWNSHIP 3-SOUTH, RANGE 17-EAST, AND RUN THENCE N.89°18'E., ALONG THE NORTH LINE OF SAID SOUTHEAST ONE QUARTER (SE/4), 38.20 FEET, THENCE SOUTH, 145.00 FEET, TO THE POINT-OF-BEGINNING, AND RUN THENCE N.89°18'E, PARALLEL TO SAID NORTH LINE, 177.20 FEET, THENCE NORTH, 97.85 FEET, TO THE SOUTH RIGHT-OF-WAY LINE OF LONG STREET, THENCE N. 89°18'E. ALONG SAID SOUTH RIGHT-OF-WAY LINE, 235.42 FEET, THENCE 5.2°43'W., 338.54 FEET, THENCE N.89°44'E., 296.30 FEET, THENCE 5.25842 W. 138.77 FEET, THENCE N.872608 W., 98.38 FEET, THENCE 5.4°2945 W. 127 18 FEET, TO THE NORTH RIGHT-OF-WAY LINE OF WILSON STREET, THENCE N.85°52'40"W. ALONG SAID NORTH RIGHT-OF-WAY LINE, 555. 96 FEET, TO THE POINT-OF-INTERSECTION OF SAID NORTH RIGHT-OF-WAY LINE WITH THE EAST RIGHT-OF-WAY LINE OF STATE ROAD NO. S-250, THENCE N. 1°21'E., ALONG SAID EAST RIGHT-OF-WAY LINE, 196.66 FEET TO THE POINT-OF-A-CURVE, THENCE NORTHERLY ALONG SAID CURVE, CONCAVE TO THE LEFT, WITH A RADIUS OF 387.03 FEET, ALONG A CHORD BEARING N.9°52'20"W., A DISTANCE OF 153.51 FEET, THENCE NORTH, 107.00 FEET, TO THE POINT-OF-BEGINNING.
