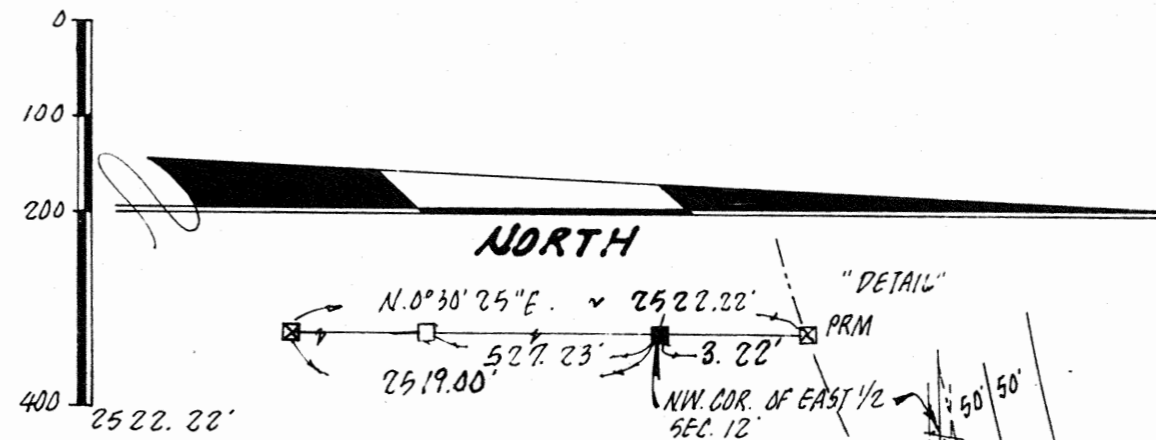

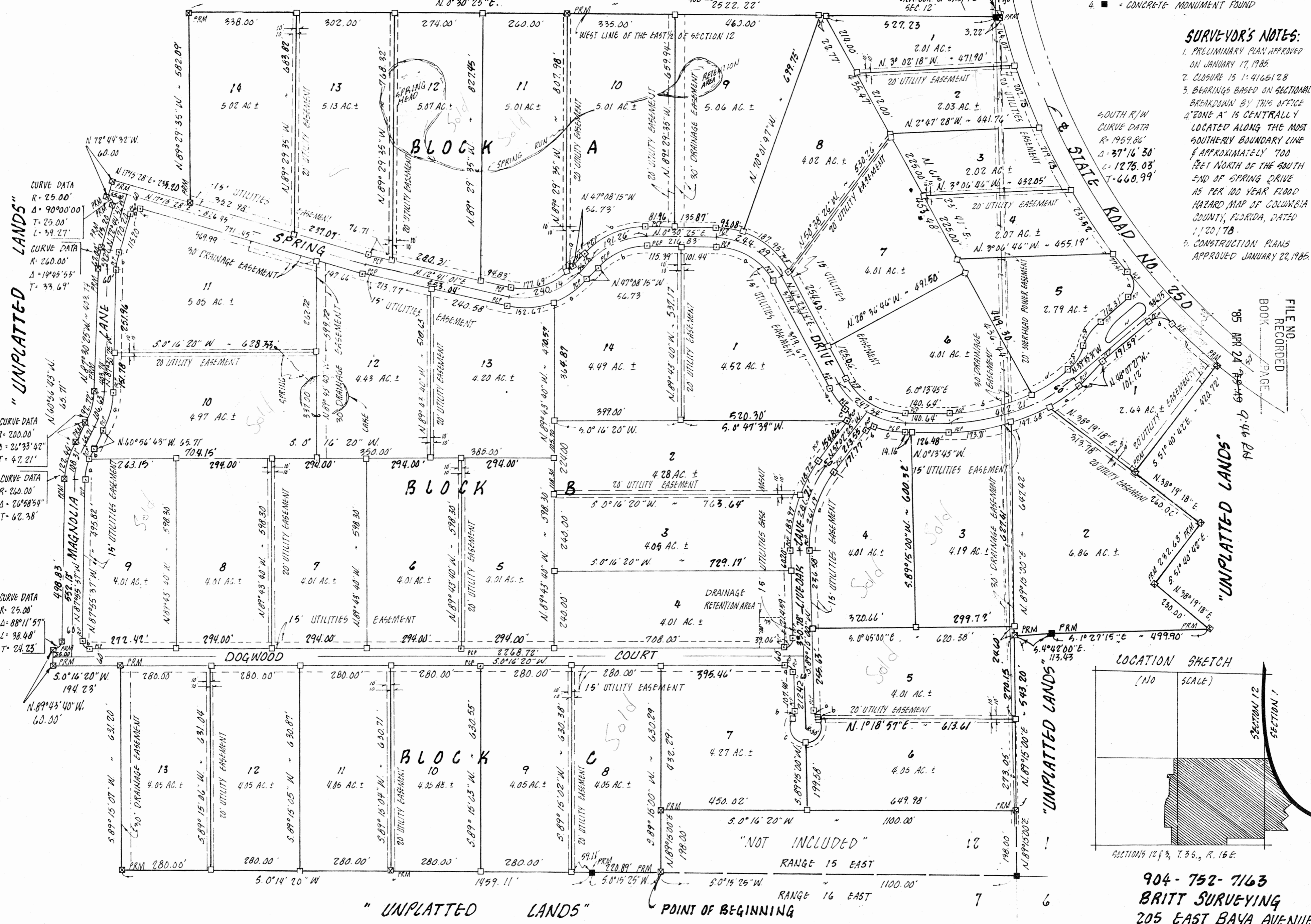

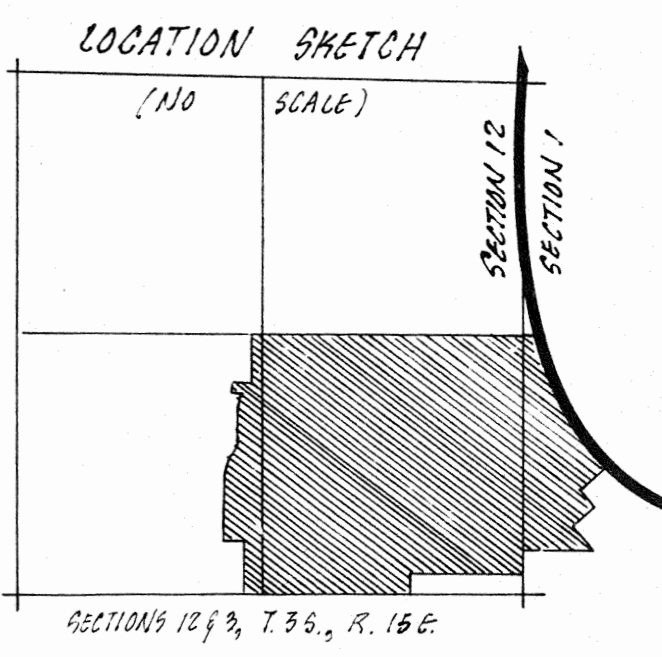

ALONG SAID EASTERLY RIGHT-OF-WAY LINE, 194.23 FEET TO THE SOUTHERLY END AND TERMINATION POINT OF SAID DOGWOOD COURT; THENCE N.89°43'40"W. ALONG THE SOUTHERLY END OF SAID DOGWOOD COURT, 60.00 FEET TO A POINT OF CURVATURE OF A CURVE TO THE LEFT HAVING A RADIUS OF 25 FEET AND A CENTRAL ANGLE OF 88°11'57"; THENCE NORTHWESTERLY ALONG SAID CURVE AND ALONG THE COMMON RIGHT-OF-WAYS OF SAID DOGWOOD COURT AND MAGNOLIA LANE, AN ARC DISTANCE OF 38.48 FEET TO THE TERMINATION POINT OF SAID CURVE; THENCE N.87°55'37"W. ALONG THE SOUTH RIGHT-OF-WAY LINE OF SAID MAGNOLIA LANE, 498.83 FEET TO THE POINT OF CURVATURE OF A CURVE TO THE RIGHT HAVING A RADIUS OF 260.00 FEET AND AN INCLUDED ANGLE OF 26°58'54"; THENCE NORTHWESTERLY ALONG THE SOUTH RIGHT-OF-WAY LINE OF SAID MAGNOLIA LANE AN ARC DISTANCE OF 122.44 FEET TO THE TERMINATION POINT OF SAID CURVE; THENCE N.60°56'43"W. ALONG THE SOUTH RIGHT-OF-WAY LINE OF SAID MAGNOLIA LANE, 65.71 FEET TO THE POINT OF A CURVE TO THE LEFT HAVING A RADIUS OF 200.00 FEET AND AN INCLUDED ANGLE OF 26°33'42"; THENCE NORTHWESTERLY ALONG THE SOUTH RIGHT-OF-WAY LINE OF SAID MAGNOLIA LANE AND ALONG THE ARC OF SAID CURVE, 92.72 FEET TO THE TERMINATION POINT OF SAID CURVE; THENCE N.87°30'25"W. ALONG THE SOUTH RIGHT-OF-WAY LINE OF SAID MAGNOLIA LANE, 403.74 FEET TO THE POINT OF CURVATURE OF A CURVE TO THE RIGHT HAVING A RADIUS OF 260.00 FEET AND AN ANGLE OF 14°45'53"; THENCE NORTHWESTERLY ALONG THE SOUTH RIGHT-OF-WAY LINE OF SAID MAGNOLIA LANE AND ALONG THE ARC OF SAID CURVE, 67.00 FEET TO THE TERMINATION POINT OF SAID CURVE; THENCE N.72°44'36"W. ALONG THE SOUTH RIGHT-OF-WAY LINE OF SAID MAGNOLIA LANE, 152.00 FEET TO THE POINT OF CURVATURE OF A CURVE TO THE LEFT HAVING A RADIUS OF 25.00 FEET AND AN INCLUDED ANGLE OF 90°00'00"; THENCE SOUTHWESTERLY ALONG THE COMMON RIGHT-OF-WAYS OF SAID MAGNOLIA LANE AND SPRING DRIVE, AN ARC DISTANCE OF 39.27 FEET TO THE SOUTH END OF SAID SPRING DRIVE; THENCE N.72°44'32"W. ALONG THE SOUTH END OF SAID SPRING DRIVE, 60.00 FEET TO THE WEST RIGHT-OF-WAY LINE OF SAID SPRING DRIVE; THENCE N.17°15'28"W. ALONG THE WEST RIGHT-OF-WAY LINE OF SAID SPRING DRIVE, 235.20 FEET; THENCE N.89°29'36"W. 582.09 FEET TO THE WEST LINE OF THE EAST 1/2 OF SAID SECTION 12; THENCE N.0°30'25"E. ON A PROLONGATION OF THE WEST LINE OF SAID EAST 1/2, A DISTANCE OF 3.22 FEET TO THE SOUTH RIGHT-OF-WAY LINE OF STATE ROAD NO. 250, SAID POINT BEING ON THE ARC OF A CURVE TO THE LEFT HAVING A RADIUS OF 1959.84 FEET AND AN INCLUDED ANGLE OF 37°14'30"; THENCE NORTHEASTERLY ALONG THE SOUTH RIGHT-OF-WAY LINE OF SAID STATE ROAD NO. 250 AND ALONG THE ARC OF SAID CURVE, 1275.03 FEET; THENCE S.51°40'42"E. 420.70 FEET; THENCE N.38°19'18"E. 260.00 FEET; THENCE S.51°40'42"E. 232.63 FEET; THENCE N.38°19'18"E. 230.00 FEET; THENCE S.1°27'15"E. 499.90 FEET; THENCE S.4°02'02"E. 113.43 FEET TO THE SOUTH LINE OF SAID SECTION 1 AND THE NORTH LINE OF SAID SECTION 12; THENCE N.89°15'00"E.
