
BOUNDARY SURVEY

IN SECTION 7 & 18 TOWNSHIP 5 SOUTH, RANGE 17 EAST COLUMBIA COUNTY, FLORIDA



DESCRIPTION:

A parcel of land in Sections 7 and 18, Township 5 South, Range 17 East, Columbia County, Florida, being more particularly described as follows:

COMMENCE at the Northeast corner of Section 18, Township 5 South, Range 17 East, Columbia County, Florida and run South 88'24'04" West along the North line of Section 18 a distance of 1318.26 feet; thence South 56'41'15" West a distance of 117.79 feet; thence South 83'22'09" West a distance of 686.53 feet: thence South 87'03'43" West a distance of 1273.11 feet to the East line of a proposed road; thence South 87°06'47" West a distance of 60.00 feet to the West line of said proposed road and the POINT OF BEGINNING; thence South 87°56'11" West a distance of 1242.83 feet; thence North 02°53'14" West a distance of 695.07 feet to the South line of a proposed road; thence North 87.06'46" East along said South line of a proposed road a distance of 1212.70 feet to the Southwest line of a proposed road; thence South 47.53'14" East along said Southwest line of a proposed road a distance of 42.43 feet to the West line of a proposed road; thence South 02.53'14" East along said West line a distance of 682.93 feet to the POINT OF BEGINNING. Containing 20.07 acres, more or less.

COMMENCE at the Northeast corner of Section 18, Township 5 South, Range 17 East, Columbia County, Florida and run South 88°24'04" West along the North line of Section 18 a distance of 1318.26 feet; thence South 56'41'15" West a distance of 117.79 feet; thence South 83'22'09" West a distance of 686.53 feet; thence South 87°03'43" West a distance of 1273.11 feet to the East line of a proposed road and the POINT OF BEGINNING; thence South 02°53'14" East along said East line a distance of 113.08 feet to a point on the Northerly Right-of-Way line of SW Custom Made Circle; thence South 86.45.59" West along said Northerly Right—of—Way line a distance of 60.00 feet to the West line of a proposed road; thence North 02.53'14" West along said West line a distance of 796.37 feet; thence North 87.06'46" East a distance of 60.00 feet to a point on the East line of a proposed road; thence South 02°53'14" East along said East line a distance of 682.93 feet to the POINT OF BEGINNING.




