CORNER OF ODOM HEIGHTS AS RECORDED IN PLAT BOOK 2 AT PAGE 120, PUBLIC RECORDS OF COLUMBIA COUNTY, FLORIDA AND RUN THENCE N. 88° 15' E. 148 FEET TO POINT OF BEGINNING; AND RUN THENCE N. 88° 15' E. ALONG THE SOUTH LINE OF SAID ODOM HEIGHTS, 772.9 FEET TO THE S.E. CORNER OF SAID ODOM HEIGHTS; THENCE S. 1° 51' E. 350.0 FEET; THENCE S. 88° 15' W. 837.8 FEET; THENCE N. 8° 03' E. 353.45 FEET TO POINT OF BEGINNING.

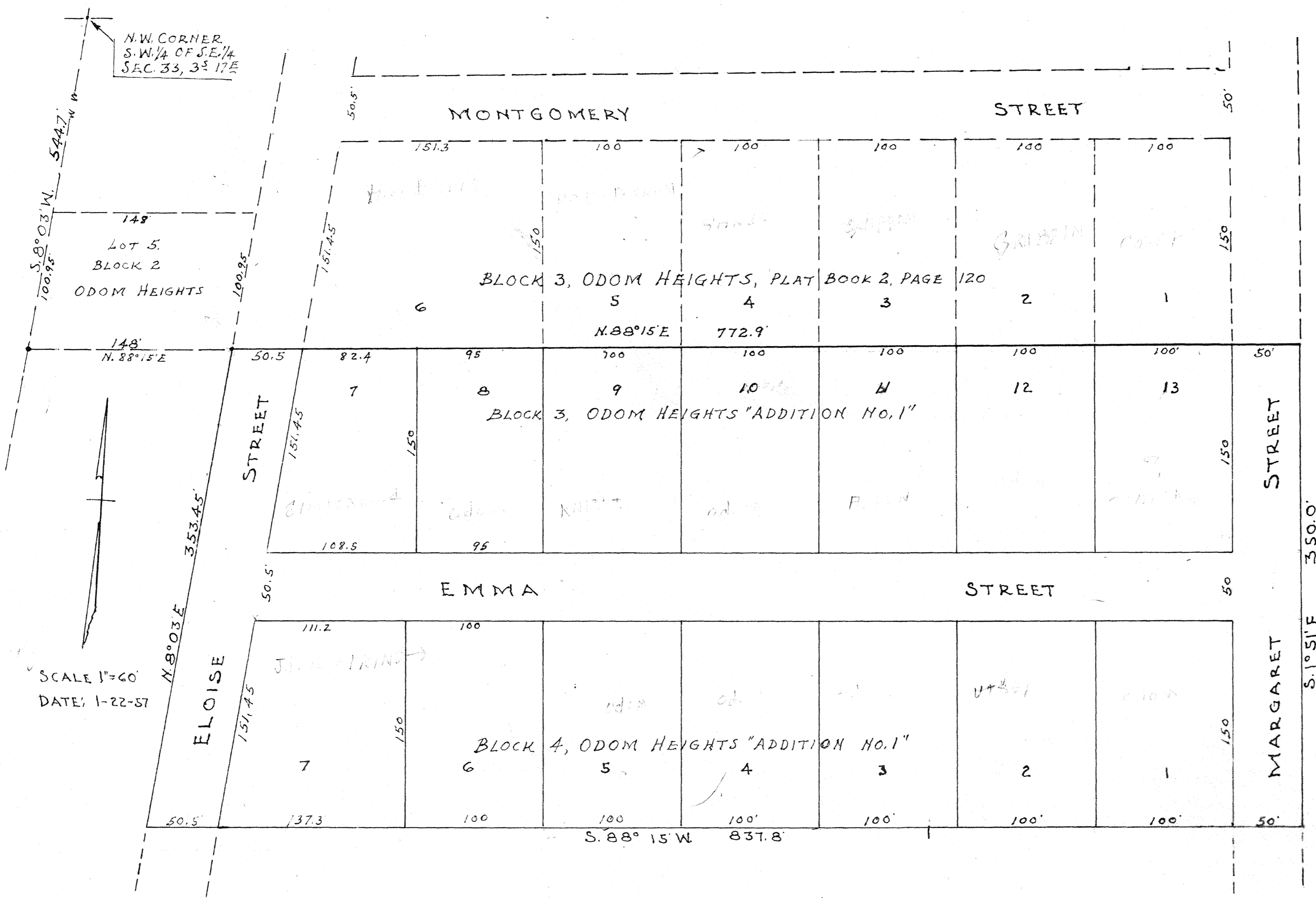
