DESCRIPTION

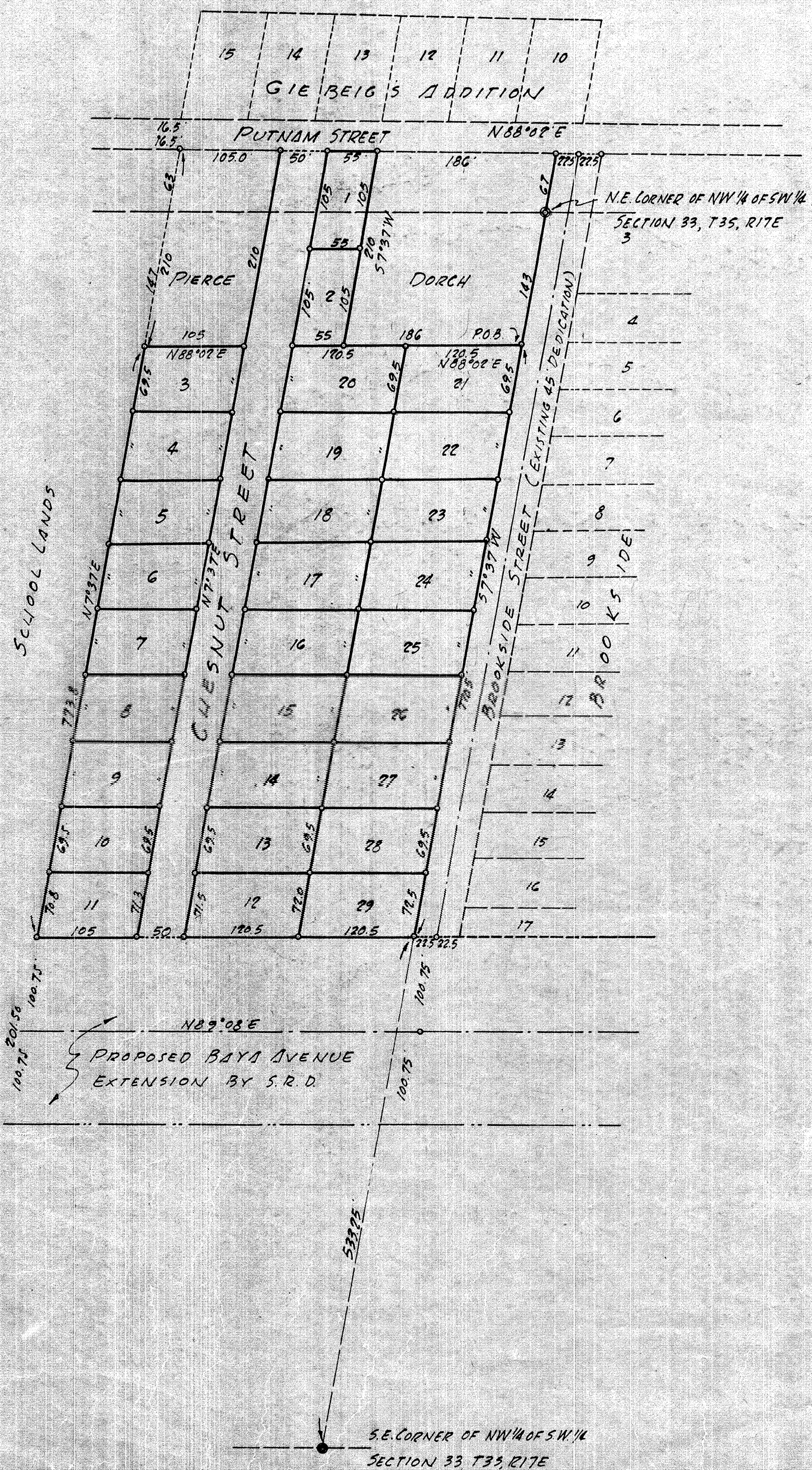
Commence at the NE corner of the NW 1/4 of the SW 1/4, Section 33, T35, R17E, and run thence along the East line of said NW 1/4 of SW 1/4 a distance of 143' for a POINT OF BEGINNING; thence continuing along this line run 770.5' to the North Right of Way Line of Baya Avenue Extension (aforesaid line having a bearing of S 7°37' W); thence run S 89°08' W along said North Right of Way Line of Baya Avenue Extension a distance of 396'; thence run N 7°37' E a distance of 773.8'; thence run N 88°02' E a distance of 105' to the West line of Chestnut Street; thence run N 7°37' E along said West line of Chestnut Street a distance of 210' to the South line of Putnam Street; thence run N 88°02' E along said South line of Putnam Street a distance of 105'; thence run S 7°37' W a distance of 210'; thence run N 88°02' E a distance of 186' to the POINT OF BEGINNING, said lands being a part of and situated in the NW 1/4 of the SW 1/4, SECTION 33, T35, R17E, Columbia County, Florida.
