A portion of the Northeast 1/4 of the Northeast 1/4 of Section 21 TOGETHER WITH a portion of Section 22, all being in Township 6 South, Range 17 East, Columbia County, Florida and being more particularly described as follows: BEGIN at the Northwest corner of the Southwest 1/4 of the Northwest 1/4 of said Section 22; thence South 01°45'29" East along the West line of the Southwest 1/4, of the Northwest 1/4, a distance of 285.00 feet; thence North 88°06'25" East, parallel to the North line of the Southwest 1/4 of the Northwest 1/4 of said Section 22, a distance of 1040.10 feet to a point, 420.00 feet Westerly of, as measured along the Easterly prolongation of the last said line from the Westerly right-of-way line of State Road No. 25 (U.S. Highway 41 and 441, as per S.R.D.
