

### **DEDICATION:**

KNOW ALL MEN BY THESE PRESENTS THAT BARNETT BANK OF NORTH CENTRAL FLORIDA, AS OWNER KNOW ALL MEN BY THESE PRESENTS THAT BARNETT BANK OF NORTH CENTRAL FLORIDA, AS OWNER HAS CAUSED THE LANDS HEREON SHOWN TO BE SURVEYED, SUBDIVIDED AND PLATTED, TO BE KNOWN AS "QUAIL RIDGE ESTATES, UNIT 1", AND THAT ALL ROADS, STREETS, ALLEYS AND OTHER RIGHTS OF WAY, AND ALL EASEMENTS SHOWN ON THE PLAT, OTHER THAN THE DRAINAGE EASEMENT AREA AND POND, ARE HEREBY DEDICATED TO THE PERPETUAL USE OF THE PUBLIC. ALL UTILITY EASEMENTS, SHOWN ON THIS PLAT, SHALL CONSTITUTE EASEMENTS FOR THE CONSTRUCTION, INSTALLATION, MAINTENANCE AND OPERATION OF ELECTRIC, TELEPHONE, CATV, WATER AND SEWER UTILITIES AND ANY AND ALL OTHER PUBLIC OR PRIVATE UTILITIES WHICH MAY SERVE THE LANDS ENCOMPASSED BY OR IN THIS PLAT. THE POND AND DRAINAGE EASEMENT AREA DEPICTED AND DELINEATED ON THE PLAT AND THE SURFACEWATER MANAGEMENT SYSTEM ARE NOT DEDICATED TO THE PUBLIC, BUT RATHER ARE DEDICATED TO THE OWNERS OF THE LOTS INCLUDED IN THE PLAT WHO SHALL ASSUME THE RESPONSIBILITIES FOR ALL PROPER AND CONTINUOUS MAINTENANCE THEREOF THROUGH A PROPERTY OWNERS' ASSOCIATION.
