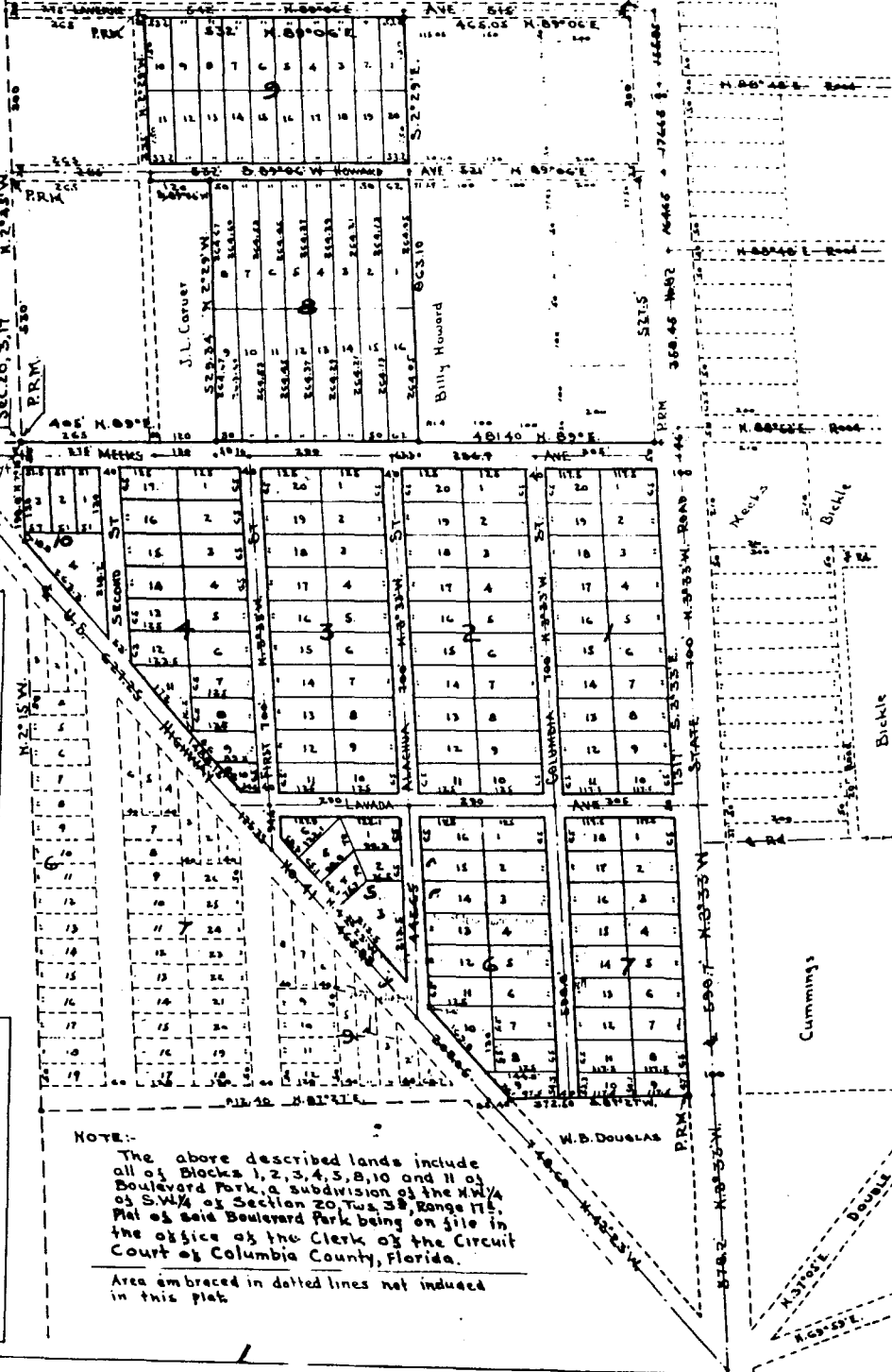


RUBY PARK

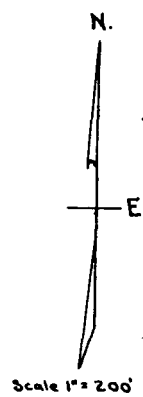
DESCRIPTION

Begin at the N.W. Corner of N.W. 1/4 of SW 1/4, Section 20, Twp. 28, Range 17E and run N. 89° E. 405 feet, thence N. 2° 29' W. 528.24 feet, thence S. 89° 04' W. 120 feet, thence N. 2° 29' W. 335 feet, thence N. 89° 04' E. 332 feet, thence S. 2° 29' E. 663.10 feet, thence N. 89° E. 401.40 feet, thence S. 2° 33' E. 1317 feet, thence S. 87° 27' W. 312.5 feet, thence N. 42° W. 1486.15 feet, thence N. 2° 15' W. 198.8 feet to P.O.B. Said lands being in the N.W. 1/4 of SW 1/4 and SW 1/4 of SW 1/4 of said Section 20.
