

Begin at the N.W. corner of N.W. 1/4 of S.W. 1/4, Section 20, Range 11, and run N. 89° 46' E., 405 feet, thence N. 21° 29' W., 529.34 feet, thence S. 89° 46' W., 120 feet, thence N. 29° 28' W., 335 feet, thence N. 89° 46' E., 532 feet, thence S. 21° 28' E., 863.10 feet, thence N. 89° 46' E., 401.40 feet, thence N. 21° 28' W., 1317 feet, thence S. 87° 27' W., 312.5 feet, thence N. 42° W., 1400.15 feet, thence N. 21° 15' W., 198.8 feet to P.O. Said lands being in the N.W. 1/4 of S.W. 1/4, and containing 10.96 acres.
