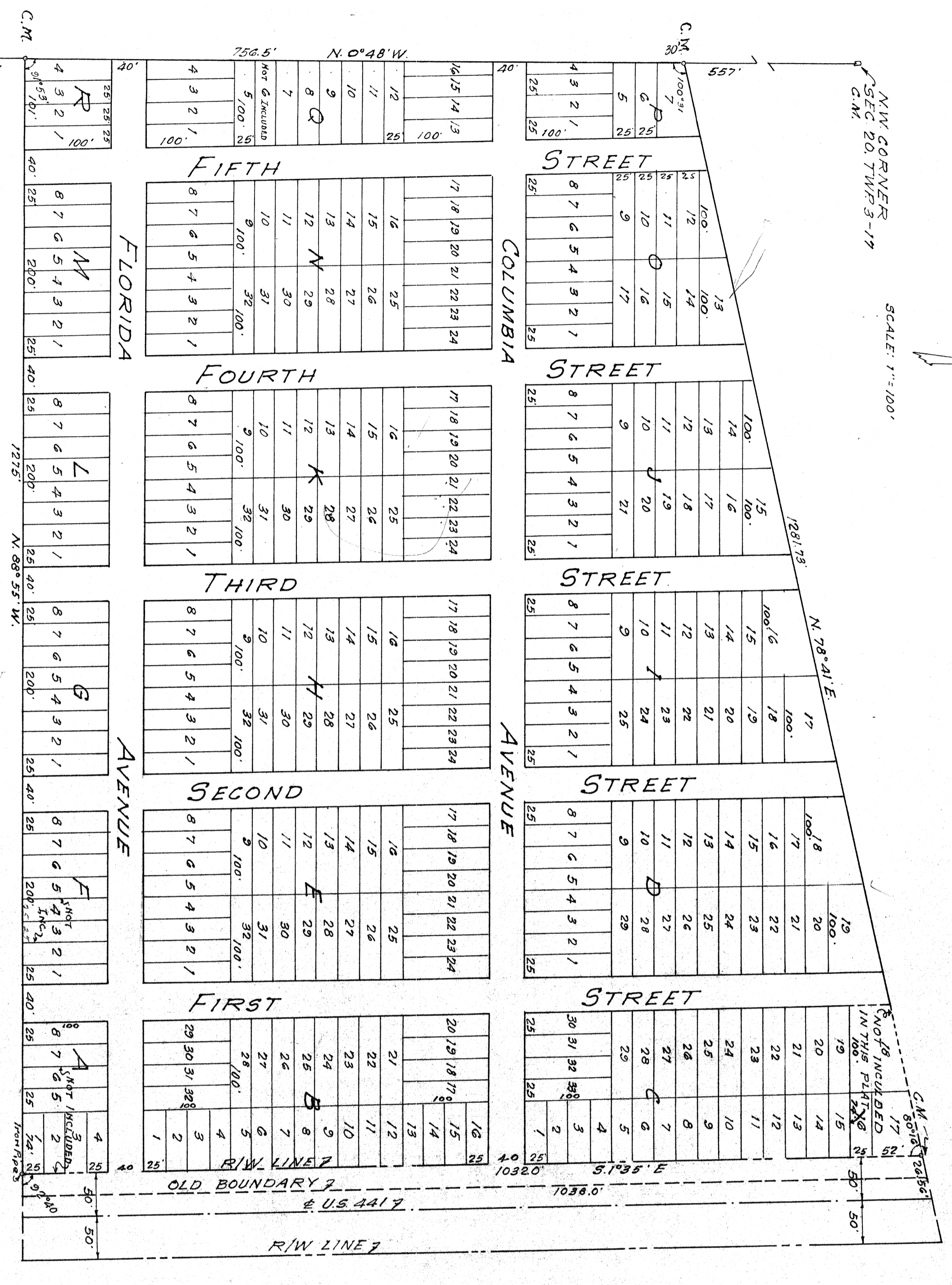


S. C. ALBRITTONS REPLAT OF SPRINGFIELD

A SUBDIVISION OF A PART OF THE NORTHWEST 1/4 OF NORTHWEST 1/4 OF SECTION 20, TOWNSHIP 3 SOUTH, RANGE 17 EAST, COLUMBIA COUNTY, FLORIDA

DESCRIPTION

COMMENCE AT THE NORTHWEST CORNER OF SECTION 20, TOWNSHIP 3 SOUTH, RANGE 17 EAST AND RUN SOUTH ALONG THE WEST LINE OF SAID SECTION 20, 557 FEET FOR A POINT OF BEGINNING AND RUN THENCE N. 78° 41' E. 1281.73 FEET TO THE WEST LINE OF U.S. HIGHWAY N. 441, THENCE S. 1° 35' E. 1275 FEET TO THE WEST LINE OF SAID R/W LINE 1032 FEET, THENCE N. 89° 55' W. 1275 FEET TO THE WEST LINE OF SAID SECTION 20, THENCE N. 0° 44' W. 756.5 FEET TO POINT OF BEGINNING.
