

COMMENCE AT THE SOUTHEAST CORNER OF SECTION 20, TOWNSHIP 4 SOUTH, RANGE 16 EAST, COLUMBIA COUNTY, FLORIDA AND RUN THENCE N 1° 04' 48" W ALONG THE EAST LINE OF SAID SECTION 20, 3.57 FEET TO THE NORTH RIGHT-OF-WAY LINE OF COUNTY ROAD NO. C-242 AND TO THE POINT OF BEGINNING, THENCE S 89° 03' 30" W ALONG SAID NORTH RIGHT-OF-WAY LINE, 211.64 FEET, THENCE N 0° 56' 30" W, 546.11 FEET TO THE SOUTH-EASTERLY RIGHT-OF-WAY LINE OF STATE ROAD NO. 247, THENCE N 41° 30' 00" E ALONG SAID SOUTHEASTERLY RIGHT-OF-WAY LINE, 939.93 FEET, THENCE S 0° 39' 54" E, 1239.31 FEET TO THE NORTH RIGHT-OF-WAY LINE OF COUNTY ROAD NO.
