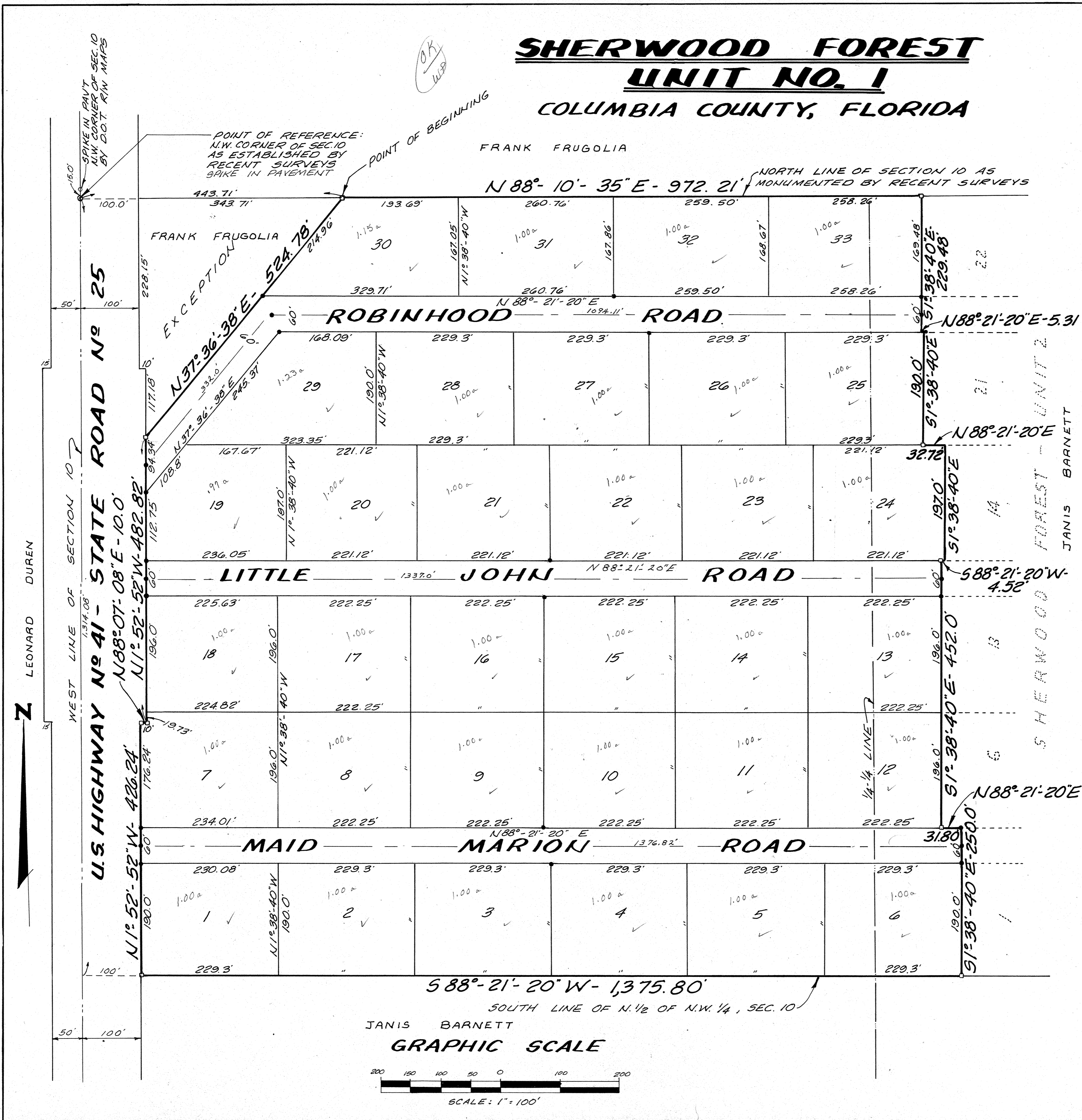

PART OF THE NORTH 1/2 OF THE NORTHWEST 1/4 OF SECTION 10, TOWNSHIP 7 SOUTH, RANGE 17 EAST, COLUMBIA COUNTY, FLA., BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

FOR POINT OF REFERENCE COMMENCE AT A SPIKE IN PAVEMENT OF STATE ROAD NO. 25 (U.S. HIGHWAY NO. 41), SAID SPIKE BEING SET AT THE NORTHWEST CORNER OF SAID SECTION 10 AS MONUMENTED BY RECENT SURVEYS AND RUN NORTH 88°-10'-35" EAST, ALONG THE NORTH LINE OF SAID SECTION 10 AS MONUMENTED BY RECENT SURVEYS, A DISTANCE OF 443.71 FEET TO A CONCRETE MONUMENT FOR THE POINT OF BEGINNING.

FROM POINT OF BEGINNING THIS DESCRIBED CONTINUE THENCE NORTH 88°-10'-35" EAST, ALONG SAID LAST MENTIONED NORTH LINE, A DISTANCE OF 972.21 FEET TO A CONCRETE MONUMENT; RUN THENCE SOUTH 1°-38'-40" EAST, A DISTANCE OF 229.48 FEET TO A POINT; RUN THENCE NORTH 88°-21'-20" EAST, A DISTANCE OF 5.31 FEET TO A CONCRETE MONUMENT; RUN THENCE SOUTH 1°-38'-40" EAST, A DISTANCE OF 190.0 FEET TO A CONCRETE MONUMENT; RUN THENCE NORTH 88°-21'-20" EAST, A DISTANCE OF 32.72 FEET TO A POINT; RUN THENCE SOUTH 1°-38'-40" EAST, A DISTANCE OF 197.0 FEET TO A POINT; RUN THENCE SOUTH 88°-21'-20" WEST, A DISTANCE OF 4.52 FEET TO A CONCRETE MONUMENT; RUN THENCE SOUTH 1°-38'-40" EAST, A DISTANCE OF 250.0 FEET TO A CONCRETE MONUMENT ON SOUTH LINE OF THE NORTH 1/2 OF SAID NORTHWEST 1/4 OF SECTION 10; RUN THENCE SOUTH 88°-21'-20" WEST, ALONG SAID LAST MENTIONED SOUTH LINE, A DISTANCE OF 1,375.80 FEET TO A CONCRETE MONUMENT ON THE EAST RIGHT-OF-WAY LINE OF SAID STATE ROAD NO. 25; RUN THENCE THE FOLLOWING COURSES AND DISTANCES ALONG SAID EAST RIGHT OF WAY LINE OF STATE ROAD NO. 25: 1<sup>ST</sup> COURSE: NORTH 1°-52'-52" WEST, A DISTANCE OF 426.24 FEET TO A CONCRETE MONUMENT; 2<sup>ND</sup> COURSE: NORTH 88°-07'-08" EAST, A DISTANCE OF 10.0 FEET TO A CONCRETE MONUMENT; 3<sup>RD</sup> COURSE NORTH 1°-52'-52" WEST, A DISTANCE OF 482.82 FEET TO A CONCRETE MONUMENT; RUN THENCE NORTH 37°-36'-38" EAST, A DISTANCE OF 524.78 FEET TO THE POINT OF BEGINNING. THE LANDS THUS DESCRIBED CONTAIN 38.85 ACRES, MORE OR LESS.
