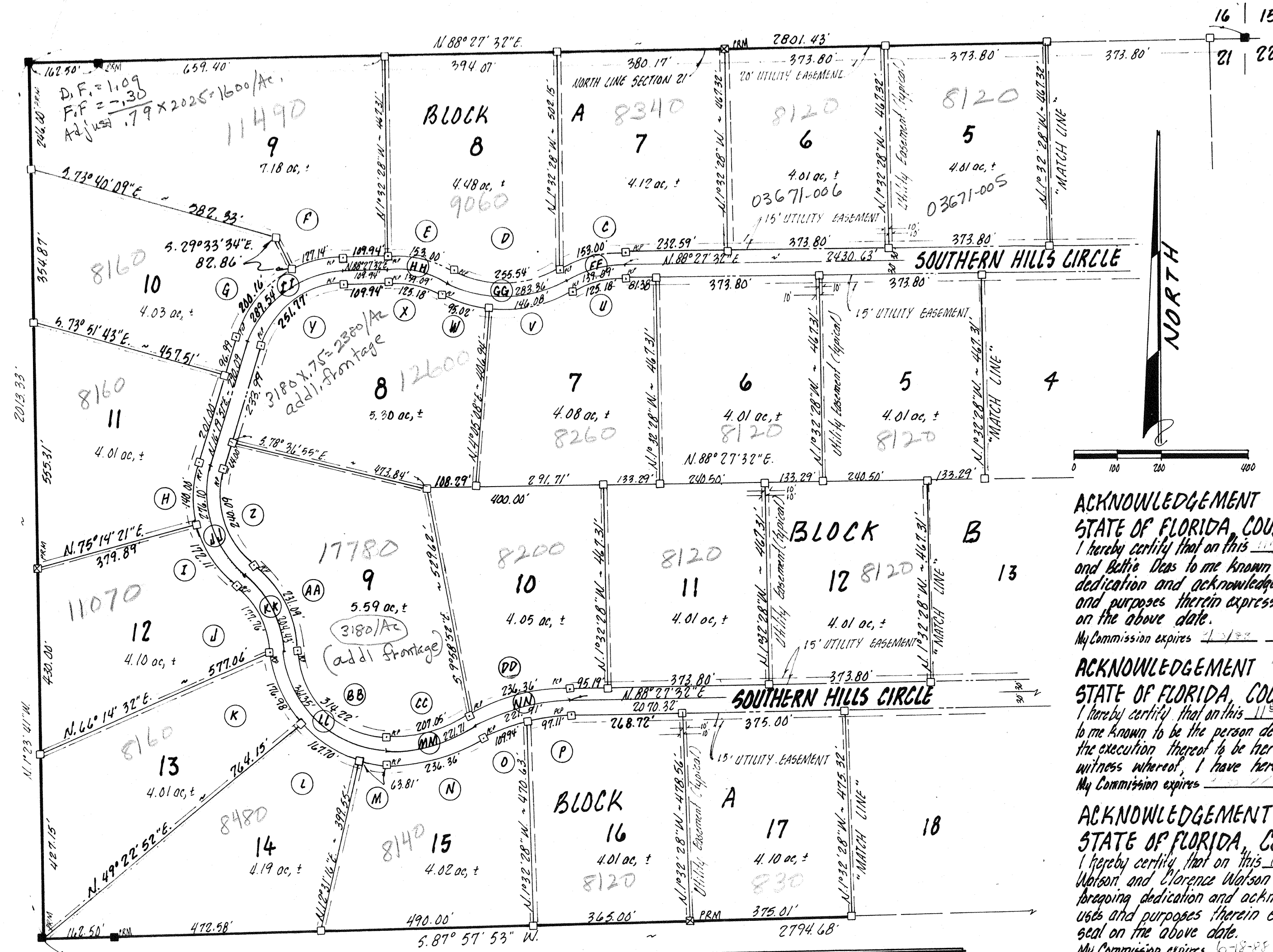

### DESCRIPTION

BEGIN at the Northwest Corner of Section 22, Township 5 South, Range 16 East, Columbia County, Florida and thence N. 88° 11' 41" E, along the North line of said Section 22 and along the South right-of-way line of Kirby Pitt Road, a distance of 1424.40 feet; thence S. 59° 11' 35" E, along the South right-of-way line of said Kirby Pitt Road, 160.38 feet to the West right-of-way line of an abandoned railroad; thence S. 14° 23' 19" W, along the West right-of-way line of said abandoned railroad, 2069.24 feet; thence S. 88° 05' 00" W, 1028.68 feet to the West line of said Section 22; thence S. 87° 57' 53" W, 2794.68 feet; thence N. 1° 23' 41" W, 2013.33 feet to the North line of Section 21, Township 5 South, Range 16 East; thence N. 88° 27' 32" E, along the North line of said Section 21, a distance of 2802.43 feet to the Northeast corner of said Section 21 and the POINT OF BEGINNING.

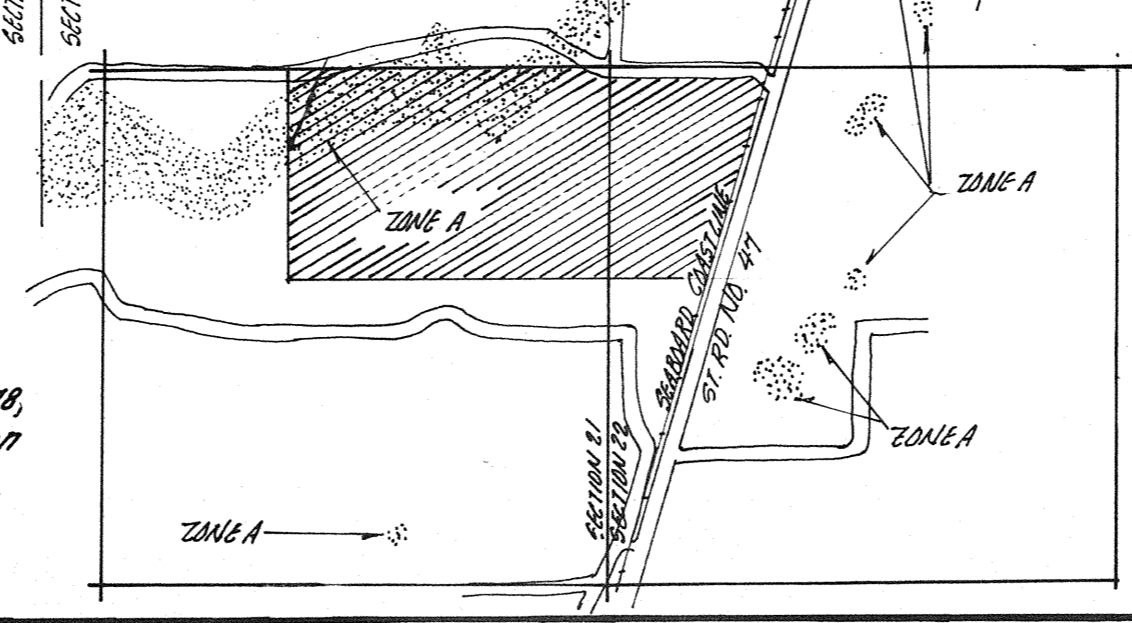
