Commence at the Northwest Corner Section 25 and run South 65°52' East 531.32 feet for a Point of Beginning on the Northeastly Right of Way line Florida Power Corporation 100 Foot Steel Tower Line Easement; thence South 61°59' West 2232.00 feet; thence South 28°01' East 3149.14 feet; thence North 50°53' East 5493.5 feet; thence North 78°51' East 1185.00 feet; thence South 70°08' East 759.99 feet; to a point on the Southeastly Right of Way line Power Line; thence North 61°59' East 100.00 feet to Northeastly Right of Way line; thence North 28°01' West 3906.16 feet to the Point of Beginning; being a part of Sections 25 and 26, Township 6 South, Range 15 East, Columbia County, Florida. Bearings refer to Lambert Grid.
