Commence at the Northwest corner of the Northwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$, Section 15, Township 4 South, Range 17 East, Columbia County, Florida and run S. $1^{\circ} 25' 46''$ E. along the West line of said Section 15 a distance of 544.02 feet; thence N. $88^{\circ} 41' 16''$ E. 121.16 feet to the POINT OF BEGINNING; thence continue N. $88^{\circ} 41' 16''$ E. 60.00 feet; thence N. $1^{\circ} 14' 10''$ W. 161.34 feet; thence N. $88^{\circ} 41' 16''$ E. 1090.00 feet to the West right of way line of State Road S-133; thence S. $1^{\circ} 14' 10''$ E. along said West right of way line 382.68 feet; thence S. $88^{\circ} 41' 16''$ W. 1090.00 feet; thence S. $1^{\circ} 14' 10''$ E. 161.34 feet; thence S. $88^{\circ} 41' 16''$ W. 60.00 feet; thence N. $1^{\circ} 14' 10''$ W. 382.67 feet to the POINT OF BEGINNING.
