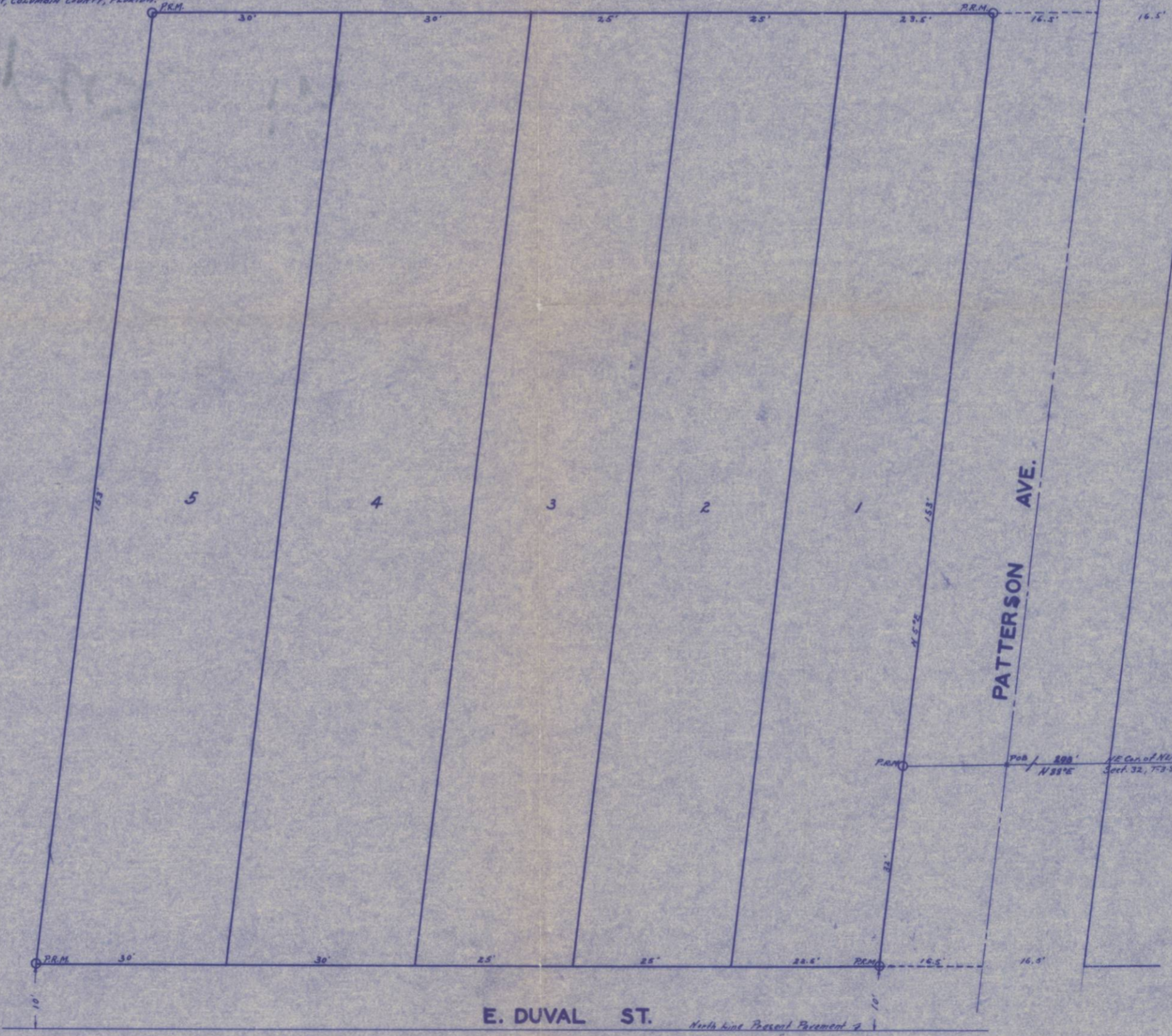

Said tract lying and being partly in NE¹/₄ of NE¹/₄ Sec. 32, T-3-S, R-17-E, and partly in SE¹/₄ of NE¹/₄ of Sec. 32, T-3-S, R-17-E, also being a part of Blocks 234 and 247 Eastern Division of Lake City, Columbia County, Florida, P.M.
