COMMENCE at the Northwest corner of the Southwest 1/4 of Section 6, Township 7 South, Range 16 East, Columbia County, Florida and run South 00°15'08" East along the West line of said Section 6 a distance of 33.01 feet to a point on the South line of Wilson Springs Road as deeded to Columbia county; thence North 88°10'31" East along said South line of Wilson Springs Road as deeded to Columbia county a distance of 868.44 feet; thence South 05°14'33" West a distance of 256.06 feet; thence South 25°17'56" West a distance of 125.00 feet to the POINT OF BEGINNING; thence South 57°17'41" East a distance of 550.00 feet to a point on the Westerly Right-of-Way line of SW Memorial Drive: thence South 32°41'02" West along said Westerly Right-of-Way line of SW Memorial Drive a distance of 185.00 feet to a point on the North line of Wilson Springs Community Phase 1-A, an unrecorded subdivision; thence North 57°17'41" West along said North line of Wilson Springs Community Phase 1-A, an unrecorded subdivision, a distance of 526.02 feet; thence North 25°17'56" East a distance of 186.56 feet to the POINT OF BEGINNING. 
